COMPLAINANT STATEMENT IN SUPPORT OF THIS RESOLUTION

ON OR AROUND 11:45am - 12 NOON -
WHILE STANDING AT THE REGISTER
AREA OF THE KENTUCKY FRIED CHICKEN
LOCATED AT WRIGHTSBORO ROAD
AUGUSTA GEORGIA, A BLACK FEMALE
WITH NO NAME TAG WALKED UP

TO THE REGISTER AND BEGIN TAKING
SEVERAL ORDERS, AFTER GETTING DOWN
TO THE LAST THREE PERSONS IN
LINE AND I BEING AROUND THE
SECOND PERSON, THE "BLACK FEMALE"
BEGAN PULLING UP HER UNIFORM SHIRT
AND RUBBING HER STOMACH IN A SEDUCTIVE
MANNER. THE FEMALE MADE THAT
SAME GESTURE AT LEAST 2 OR 3 TIMES
WHILE DURING THE LAST EPISODE
OF RUBBING, THE "BLACK FEMALE"
LEFT THE SHIRT UP AND JUST CONTINUED
RUBBING HER STOMACH. WHILE WORKING AT
FRONT REGISTER AND RECEIVING MONEY FROM
CUSTOMERS THE BLACK FEMALE HAD NO
SHIRT UNDER THE UNIFORM AND SHOWED NAKED

WHILE TAKING MY ORDER, FOR FOOD.
THE BLACK FEMALE CONCOCTED
A DEMONOR AS IF SHE WAS
SOME BAD GANGSTER THAT A
CUSTOMER OF KENTUCKY FRIED CHICKEN
HAD TO BE-SCARED OF.
THE "BLACK FEMALE" STATED
DONT SAY NOTHING TO ME.
I THEN STATED NO YOUR BEHAVIOR
UNACCEPTABLE AND YOU CANNOT
GET AN ATTITUDE BECAUSE YOU HAVE
NO RIGHT RUBBING YOUR NAKED
STOMACH IN THE FRONT OF CUSTOMERS.
"THE BLACK FEMALE" THEN STATED
YOU CAN JUST LEAVE CAUSE I
AM NOT SERVING YOU.
I STATED NO I AM NOT LEAVING
BECAUSE YOU HAVE NO RIGHT RUBBING
YOUR NAKED STOMACH IN THE FRONT
OF CUSTOMERS.
"THE BLACK FEMALE" WALKED AWAY
FROM THE REGISTER WHILE CURSING
AND SAYING "I AINT TAKING YOUR ORDER
CAUSE I CAN REFUSE SERVICE
WHO THE "FUCK" YOU THINK YOU TALKING TO
AND WENT ON AND ON CURSING WHILE
BEHIND THE COUNTER SERVING CUSTOMERS

THE "BLACK FEMALE" THEN GOT
LOUDER SAYING FOR REAL FOR REAL
SHORTY I WILL SLAP YOU
SHORTY CAUSE I WILL SLAP ANYBODY
YOU BETTER ASK SOMEBODY.
SHORTY. FOR REAL.

I STATED "YOU ARE NOT GONNA SLAP
ANYONE."

AFTER WAITING AT THE COUNTER
AN "ADDITIONAL WORKER" CAME
TO THE REGISTER AND STATED
WHAT WOULD YOU LIKE TO ORDER MA'AM.
I GAVE THE ORDER AND THE
WORKER THEN CALLED THE "BLACK FEMALE"
TO THE REGISTER AND INSTRUCTED HER
TO RING UP THE ORDER OF FOOD.
THE BLACK FEMALE WALKED OFF
FROM THE REGISTER STATING I
AIN'T TAKING HER ORDER. I CAN
REFUSE HER SERVICE. THE "ADDITIONAL
WORKER STATED "NO YOU CAN'T."
THE "ADDITIONAL WORKER" INSTRUCTED

AN EXTRA WORKER TO TAKE THE ORDER FOR FOOD
THE WORKER TOOK MY ORDER AND I
WAITED FOR FOOD WHILE "THE BLACK FEMALE"
WALKED AROUND AT THE BACK OF THE
COUNTER LIKE SHE WAS BAD AND WOULD
CAUSE A CUSTOMER OF KENTUCKY FRIED -
CHICKEN HARM WHILE SHE WORKED HER
JOB IN A UNFIT, UNPROFESSIONAL, ILLEGAL

NEGLIGENT HOSTILE MANNER. NO MANAGER SUPER-
VISED THE SITUATION EVEN AFTER SEEING AND HEARING.
