Mr. Garrett votes No. Mr. Lewis out. Motion carries 7-1.

Mr. Brown: Yes, sir.

Mr. Mayor: All right. With that concluding our motions, Madam Clerk, I consider this meeting closed and turn it over to the Public Service Committee Chairman.
