D. Amend Section 8.04 Noise of the Code of Ordinances.

Councilmember Battle gave an update to Council about what all had been done with the committee regarding the Noise Ordinance. He stated there was much discussion between the committee members and there was some discussion between the visitors and opposing arguments between both. The committee decided to do some fact finding and start reading some decibel levels. The committee chair Battle explained that quiet hours are very important. The intention was to accommodate 11th street not having to get permits every week for big acts. After much discussion between Council and all visitors Councilmember Palmer called for action.

Motion made by Councilmember Battle to approve the changes to Noise Ordinance and modify paragraph 8.04.003 number 13 to remove the last sentence Motion was amended to state striking after 75 dB(A) "when measured from the property line of the property where the sound is being received" , Seconded by Councilmember Palmer.
