BACKGROUND

The Council awarded the construction contract for the 2024 CSAH 77 Utility Improvements Project to Pratt's Affordable Excavating, Inc. on August 20, 2024, for the unit price bid of \$551,053.20. The notice to proceed was issued on August 21, 2024.

Pratt's Affordable, Inc. mobilized to the site the week of September 30, 2024, and began underground construction on Thursday, October 2, 2024.

Pay Estimate 2 is presented for approval in the amount of \$79,864.86. The payment includes all work completed between the October 25, 2024, and November 21, 2024, along with Change Order 2 in the amount of \$4,656.70.

FINANCIAL IMPLICATIONS

The Contractor has earned \$483,372.10 which represents 87% of the revised contract value. In accordance with the contract documents, retainage is being withheld in the amount of 5% of the current contract value or \$27,785.50. This results in a payment due of \$79,864.86.

The original project budget was \$852,499.27. Current expenditures, with Change Order 1 and Pay Estimate 2, are \$634,347.85. Projected final project cost is currently estimated at \$843,458.90 which leaves \$9,040.37 in contingencies in the project budget.
