**RESOLUTION ACCEPTING BID FOR THE 2026 CLEARWATER ROAD, NORTH
LYNNDALE AREA, AND BRENTWOOD CIRCLE UTILITY & STREET
IMPROVEMENTS PROJECT, MUNICIPAL PROJECT NO. 4068**

WHEREAS, pursuant to an advertisement for bids for Municipal Improvement No. 4068, the water, sanitary sewer, storm water, street, street lighting, and trail improvement of:

1. Oakwood Drive, from Welton Road to 400' southwest of Welton Road
2. Clearwater Road, from Welton Road to Memorywood Drive
3. Welton Road, from Clearwater Road to 200' north of Clearwater Road
4. Northwoods Drive, from Clearwater Road to 200' south of Clearwater Road
5. Lynndale Drive
6. Lynndale Lane
7. Lynndale Court
8. Brentwood Circle

AND WHEREAS, Bids were received, opened, and tabulated according to the law, and the following bids were received complying with the advertisement:

AND WHEREAS, it appears that RL Larson of St. Cloud, MN is the lowest responsible bidder.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BAXTER, MINNESOTA:

The mayor and clerk are hereby authorized and directed to enter into a contract with RL Larson Excavating, Inc. in the name of the City of Baxter for the improvement of:

1. Oakwood Drive, from Welton Road to 400' southwest of Welton Road
2. Clearwater Road, from Welton Road to Memorywood Drive
3. Welton Road, from Clearwater Road to 200' north of Clearwater Road
4. Northwoods Drive, from Clearwater Road to 200' south of Clearwater Road
5. Lynndale Court
6. Lynndale Lane
7. Lynndale Drive

8. Brentwood Circle

according to the plans and specifications therefor approved by the city council and on file in the office of the city clerk.

The city clerk is hereby authorized and directed to return forthwith to all bidders the deposits made with their bids, except that the deposits of the successful bidder and the next lowest bidder shall be retained until a contract has been signed.

Whereupon, said Resolution is hereby declared adopted on this 5th day of May, 2026.
