#### BACKGROUND

The Council awarded the construction contract for the 2024 CSAH 77 Utility Improvements Project to Pratt's Affordable Excavating, Inc. on August 20, 2024, for the unit price bid of \$551,053.20. The notice to proceed was issued on August 21, 2024.

Partial Pay Estimate No. 3 is presented for approval in the amount of \$17,484.69. The payment is for materials on hand stored by the Contractor for installation later this year. The Contractor is requesting payment for these stored materials because of the time extension requested by the City in Change Order No. 2. Change Order No. 2 extended the Substantial Completion date to October 10, 2025, and the final Completion Date to October 31, 2025, allowing the City additional time to secure the last easement necessary to complete the remaining utility work.

The Contract documents allow for payment of materials on hand with the submission of supplier invoice pricing information. The Engineer has reviewed the submittal and is recommending approval of the payment application.

#### **FINANCIAL IMPLICATIONS**

With Partial Pay Estimate No. 3, total payments to the Contractor will be \$473,071.29 with \$27,785.50 being withheld as retainage in accordance with the contract documents.

The original project budget was \$852,499.27. Current expenditures, with Change Order No. 1 and Partial Pay Estimate No. 3, are \$666,564.24. Projected final project cost is currently estimated at \$843,458.90 which is \$9,040.37 under the original project budget.
