

## NORTHDALE THIRD ADDITION

KNOW ALL MEN BY THESE PRESENTS: That James Tolbert and Helen Tolbert, his wife, are the owners and Gerald R. Stromberg and Elsie M. Stromberg, his wife, and James R. Matich and Beverly J. Matich, his wife, are the contract purchasers of all of Government Lot 3 and Government Lot 4, Section 1, Township 133 North, Range 29 West, Crow Wing County, Minnesota, except the following described tracts: Exception A; Commencing at the Southwest Corner of said Government Lot 4; thence North 0 degrees 58 minutes 24 seconds East, assumed bearing, along the west line of said Government Lot 4 a distance of 1170.00 feet; thence North 73 degrees 55 minutes 40 seconds East a distance of 60.00 feet to the point of beginning; thence South 22 degrees 44 minutes 45 seconds East a distance of 311.72 feet; thence South 65 degrees 08 minutes 17 seconds East a distance of 90.00 feet; thence northeasterly a distance of 140.00 feet along a non-tangential curve, concave to the southeast, having a radius of 300.00 feet, a central angle of 26 degrees 44 minutes 17 seconds and the chord of said curve bears North 38 degrees 13 minutes 52 seconds East; thence North 51 degrees 36 minutes 00 seconds East along tangent a distance of 93.65 feet; thence North 38 degrees 24 minutes 00 seconds West a distance of 290 feet, more or less, to the shore line of Red Sand Lake; thence southwesterly along said shore line to the intersection with a line bearing North 22 degrees 44 minutes 45 seconds West from the point of beginning; thence South 22 degrees 44 minutes 45 seconds East a distance of 20 feet, more or less, to the point of beginning. Exception B; Commencing at the Northeast Corner of said Government Lot 3; thence North 89 degrees 43 minutes 15 seconds West, assumed bearing, along the north line of said Government Lot 3 a distance of 538.83 feet to the point of beginning; thence South 10 degrees 55 minutes 14 seconds West a distance of 562.00 feet; thence North 83 degrees 51 minutes 07 seconds West 221.40 feet, more or less, to the shore line of Red Sand Lake; thence northeasterly along said shore line to the north line of said Government Lot 3; thence South 89 degrees 43 minutes 15 seconds East along said North line of Government Lot 3 to the point of beginning.
