BACKGROUND

The Council awarded a Contract to Pratt's Affordable Excavating Inc. at the April 1, 2025 Council Meeting in the amount of \$1,124,854.10. The construction work under this contract (Contract B) is for raw water piping and appurtenances, and electrical improvements. The work is being completed for two new production wells at the Public Works Facility/Water Treatment Plant campus.

The work represented with this payment is for work completed through March 13, 2026, and includes a reduction in retainage. Retainage is being reduced as the project is considered substantially complete. A portion of the retainage is being held to account for work items to be completed in the spring.

Partial Pay Application No. 9 is presented in the amount of \$29,661.35. SEH prepared this payment application and agrees with the amount represented.

FINANCIAL IMPLICATIONS

A project budget summary is included as Exhibit A for reference.

The Contractor has earned \$1,186,454.04 to date. Per the contract, the retainage is 2.5 percent. The summary below notes the amount due to the Contractor.
