RESOLUTION PROVIDING FOR THE COMPETITIVE NEGOTIATED SALE OF \$6,900,000 GENERAL OBLIGATION IMPROVEMENT BONDS, SERIES 2024

BE IT RESOLVED By the City Council of the City of Baxter, Crow Wing County, Minnesota ("City") as follows:

- 1. <u>Finding: Amount and Purpose</u>. It is hereby found, determined and declared that it is in the best interest of the City to issue its approximately \$6,900,000 General Obligation Improvement Bonds, Series 2024, to finance various street and utility improvements in the City.
- 2. <u>Competitive Negotiated Sale.</u> The City has retained PFM Financial Advisors LLC ("PFM") as a municipal advisor, and the City Council hereby determines to sell the Bonds pursuant to a competitive negotiated sale on Tuesday, August 20, 2024. The City Finance Director and other officers or employees of the City are hereby authorized to participate with PFM in the preparation for the sale of the Bonds. The City Council will consider proposals for the purchase of the Bonds at a meeting at 7:00 p.m., on Tuesday, August 20, 2024.
- 3. <u>Official Statement</u>. The City Council hereby authorizes the sale of the Bonds substantially in accordance with the Request for Proposals set forth in the Preliminary Official Statement dated on or after the date hereof (the "POS"). The City Council hereby authorizes PFM to distribute the POS in connection with the sale of the Bonds.
