### **BACKGROUND**

Application for Payment No. 9 is for restoration of culvert installations and sign installations on Clearwater Road and sign and delineator installation on the Quiet Zone portion of the project.

- \*\*Estimated Spent and Anticipated Final totals include approximately \$35,135 of Engineering/ Professional Services, Geotechnical, Testing that is attributed to preliminary engineering costs spent on the Section A: Full Depth Reclamation bid alternates that were not awarded. The project is currently projected to be over the 3/19/2024 approved budget by approximately \$63,495.29. The project is currently under the approved budget but will exceed but the estimated amount of \$63,495.29, a formal budget amendment will be requested in August when construction costs can more accurately be estimated.
