BACKGROUND

Soil compaction testing and material testing is necessary for the 2026 Clearwater Road, North Lynndale Area, and Brentwood Circle Street & Utility Improvements project to verify compliance with specifications. Braun has partnered with the City and SEH on numerous projects in the past several years. In addition, Braun is providing testing services on several development related projects within the City this upcoming season, and the project team would like to maintain a consistent partner for all projects in 2026.

Attached is a Braun proposal to complete construction phase testing for soil compaction, aggregate, bituminous and concrete.

FINANCIAL IMPLICATIONS

The estimated project budget is included below. Payment for this contract would be from the "Engineering- Design, Construction, Geotechnical" line item in the preliminary budget below. Council action is needed at the April 7th meeting to call for the Assessment Hearing. The proposed budget is included here for reference.
