#### **BACKGROUND**

The City hired the SEH/WiDSETH team in June 2022 to deliver this 2023 City street and utility extension project.

#### 5/28/2024 Update – Scott Hedlund, SEH

In May SEH has been continuing to chip away at pre-project closeout activities and coordinating with Kraemer Trucking & Excavating Inc. (KTE) on the project punch list. Subcontractor Design Electric addressed the remaining lighting punch list items in May. Seven (7) trees were replaced by subcontractor Doucette's Landscaping. Punch list items remaining include temporary erosion control (silt fence and bio rolls) removal and subsequent touchup seeding, and fugitive construction material cleanup in the Douglas Fir Dr/ Hastings Rd storm pond at the southeast flared end section. SEH is working toward the goal of closing out the KTE contract this summer.
