BACKGROUND

Anderson Brother's Construction Company has completed work for pedestrian ramps on Clearwater Road and Quiet Zone Improvements to CSAH 48 / Highland Scenic Road that is included in Partial Pay Estimate No. 8.

^{**}Estimated Spent and Anticipated Final totals include approximately \$35,135 of Engineering/ Professional Services, Geotechnical, Testing that is attributed to preliminary engineering costs spent on the Section A: Full Depth Reclamation bid alternates that were not awarded. The project is currently projected to be over the 6/6/2023 approved budget by approximately \$130,554.90 or 3% (which is substantially the same as reported on 3/19/2024) when excluding said \$35,135.
