Agenda Item: Approve the Tretter Trucking & Excavating, Inc. Partial Pay Estimate No. 1 in the

amount of \$62,620.65 for the 2025 Clearwater Road Dog Park Project

Approval Required: Simple Majority Vote

BACKGROUND

The Council awarded the construction contract for the 2025 Clearwater Road Dog Park Project to Tretter Trucking & Excavating, Inc. on May 6, 2025, for the lump sum bid of \$165,612.84. The notice to proceed was issued on May 13, 2025.

This partial pay estimate includes work completed between May 13, 2025, and June 20, 2025. Partial Pay Estimate No. 1 is presented in the amount \$62,620.65. This payment is for clearing and grubbing, water and sanitary utilities, earth work (approximately 90% complete), aggregate base class 5 (approximately 80% complete), dewatering, removals, and erosion control.

FINANCIAL IMPLICATIONS

The Contractor has earned \$79,181.93 to date which represents 47.8% of the contract value. This includes the \$16,561.28 held in retainage which is equal to 10% of the contract value. This period there is a payment of \$62,620.65.

The City budgeted \$371,817.51 for this project. Current expenditures with Partial Pay Estimate No. 1 are estimated at \$278,771.93. Final projected project cost is currently estimated at \$378,983.34 which is \$7,165.82 over budget. Please note, there are estimated costs included in the final project cost calculation. Better estimates of final project costs will be available as these costs become known.
