Mr. Torrez addressed the chunck holes by Hibbs Pharmacy, business says they have put in an order but have had no response. He is concerned because more businesses are coming and concerned that council does not act on it. He's noticed the city has new vehicles. concerned city is hiring plumbers to do city water work instead of city employees. fix the roads or at least patch them up.

#### **REGULAR ITEM FOR DISCUSSION, CONSIDERATION AND/OR APPROVAL**

 Agreement ~ Discuss, consider, and/or approve an Economic Development Professional Services Agreement with David Pettit Economic Development, LLC., relating to the creation of a public improvement district (PID) in the City of Bay City, Texas.

Shawna Burkhart, City Manager, stated that the agreement was assistance with the Maddox Development. David Pettit helped create the TIRZ's and we have asked for help with the Public Improvement District. Contract limits us to up to \$20,000 that is hourly based with cap. Mr. Pettit will be crunching numbers on PID and bonds. Ms. Burkhart also added that we may do a TIRZ overlay if needed. She has met with him at least 4 times with Community Development, finance and the City Attorney. He is well versed and familiar with bonds. The PID agreement is still in review and number

crunching. Mayor Pro Tem Childers stated that Mr. Pettit was very knowledgeable when he assisted with TIRZ 1, 2 and 3. Mayor says the city is not holding up the development. Ms. Burkhart added that the contract falls under professional services and is reimbursed by the developer.

# 2. Discuss, consider, and/or approve the appointment of Shea Krauskopf to the Public Housing Authority

Mayor stated that Shea Krauskopf is unable to accept the appointment, but will assist locating another candidate.

# 3. Discuss, consider, and/or approve the appointment of Donna Shook to the Public Housing Authority

Shawna Burkhart introduced Donna Shook. Ms. Shook introduced herself and gave a background of her experience in hospital administration and workforce solutions.

Motion made by Councilwoman Brown to approve the appointment of Donna Shook to the Public Housing Authority, Seconded by Mayor Pro Tem Childers. Voting Yea: Mayor Nelson, Mayor Pro Tem Childers, Councilwoman Brown, Councilman Folse, Councilwoman Sitz. Motion carried.
