## 1. Regular Council Meeting minutes of February 14, 2023.

Motion made by Councilwoman Brown to approve the consent items, Seconded by Councilman Finlay. Voting Yea: Mayor Nelson, Councilwoman Brown, Mayor Pro Tem Folse, Councilwoman Sitz, Councilman Westmoreland, Councilman Finlay. Motion carried.

## **PUBLIC HEARING**

2. Public Hearing on Business Resilience Project for Lisciotti CRE LLC.

Jessica Russell, Executive Director of BCCDC, stated that Bay City Community Development Corporation held a public hearing and the city is not required.

## REGULAR ITEMS FOR DISCUSSION, CONSIDERATION AND/OR APPROVAL

3. Resolution ~ Discuss, consider, and/or approve a Resolution authorizing the City of Bay City Community Development Corporation to enter into a contract with Bay City CFA Series LL c/o Lisciotti Development Corporation; providing incentives not to exceed a total amount of \$250,000 over the term of the agreement (First Reading).

Jessica Russell, BCCDC Executive Director, introduced the resolution as the first reading and acknowledged that Lisciotti is the developer of the Chick-Fil-A. Councilman Westmoreland requested a copy of the contract that is reference in the resolution but not provided. Thomas Gwosdz, City Assistant Attorney, stated that a Council vote is not required on the first reading.

4. Award ~ Presentation of "CiCi" award to Bay City Community Development Corporation.

Jessica Russell, BCCDC Executive Director, presented the "CiCi" awarded to BCCDC for outstanding achievement in economic development.

5. Award ~ Presentation of 2022 TMLDA Achievement of Excellence in Libraries Award.

Samantha Denbow, Library Director, presented the 2022 Texas Municipal Library Directors Association Achievement of Excellence Award.

6. Resolution ~ Discuss, consider, and/or adopt a Resolution authorizing the submission of the 2023-2024 Texas Community Development Block Grant Program application and adopting required CDBG Civil Rights policies.

Gabriel Lopez, Engineering Tech, introduced the resolution that pertains to the CDBG Grant that they have been working on and is due April 3rd. Mr. Lopez added that they have been making good progress. The grant is for water line improvement projects and match is 15 percent.

Motion made by Councilwoman Sitz to approve the resolution, Seconded by Councilman Westmoreland. Voting Yea: Mayor Nelson, Councilwoman Brown, Mayor Pro Tem Folse, Councilwoman Sitz, Councilman Westmoreland, Councilman Finlay. Motion carried.

7. Resolution ~ Discuss, consider, and/or adopt a Resolution to designate authorized signatories for the 2023-2024 Texas Community Development Block Grant program. Gabriel Lopez, Engineering Tech

Motion made by Councilwoman Sitz to approve the resolution, Seconded by Councilman. Westmoreland. Voting Yea: Mayor Nelson, Councilwoman Brown, Mayor Pro Tem Folse, Councilwoman Sitz, Councilman Westmoreland, Councilman Finlay. Motion carried.

8. Analysis ~ Discuss, consider, and/or accept the community wide housing analysis performed regarding impediments to Fair Housing for the City of Bay City as part of the grant application for the 2023-2024 Texas Community Development Block Grant program.

Gabriel Lopez, Engineering Tech, reviewed the analysis that was done by GrantWorks and due by April 3rd for the Community Development Block Grant. Councilman Westmoreland brought attention to the percentage of minorities was not adding up correctly on the first page.

Motion made by Councilwoman Sitz to accept the analysis, Seconded by Councilwoman Brown. Voting Yea: Mayor Nelson, Councilwoman Brown, Mayor Pro Tem Folse, Councilwoman Sitz, Councilman Westmoreland, Councilman Finlay. Motion carried.

9. Contract ~ Discuss, consider, and/or approve Amendment No. 1 Work Authorization No. 5 to the standard contract agreement between the City of Bay City, Texas and Garver, LLC for Professional Engineering Services for the Design, Bid, and Construction of the new North Water Plant under the Texas Water Development Board Funding Drinking Water SRF Projects.

Barry Calhoun, Public Works Director, presented the amendment to revise the design to match the East Plant capacity. Councilman Westmoreland asked if we are matching the other plant then why so much for the design if it's just a copy. A representative from Garver stated that they will need to revise the drawing because it is not the same shape. However, the plants will use the same replacement parts. Mayor Nelson added that there is a possibility that these two new wells capacity might replace the other.

Motion made by Councilwoman Brown to approve the amendment to the contract, Seconded by Councilwoman Sitz. Voting Yea: Mayor Nelson, Councilwoman Brown, Mayor Pro Tem Folse, Councilwoman Sitz, Councilman Westmoreland, Councilman Finlay. Motion carried.

10. Contract ~ Discuss, consider, and/or approve Amendment No. 1 Work Authorization No. 7 to the standard contract agreement between the City of Bay City, Texas and Garver, LLC for Professional Engineering Services for the Design, Bid, and Construction of the new East Water Plant under the Texas Water Development Board Funding Drinking Water SRF Projects.

Barry Calhoun, Public Works Director, stated that the contract originally included the Airport water well technical support, but Council direction was to put Airport aside.

Motion made by Councilwoman Brown to approve the amended contract, Seconded by Councilwoman Sitz. Voting Yea: Mayor Nelson, Councilwoman Brown, Mayor Pro Tem Folse, Councilwoman Sitz, Councilman Westmoreland, Councilman Finlay. Motion carried.
