## APPROVAL OF MINUTES

### 1. Minutes of January 13, 2021

### 2. Discuss the need for a Public Hearing.

Bill Cornman, Board Chairman, discussed the letter from the attorney and the need for a Public Hearing. The hearing has been scheduled for March 18<sup>th</sup> at Schulman's and invitations have been sent out to officials. Not many have responded to the r.s.v.p. Mr. Cornman advised James Mason, Airport Manager, to get with Crystal at Schulman's to work out technical kinks before the hearing. Julie Estlinbaum stated that Bay City Community Development has made the arrangements to stream live.

**3. Discuss the process for “flagging” owners whose property lie within the Airport Zone, as defined by the revised Ordinance.**

James Mason stated that the Attorney recommended that a letter be sent to all property owners withing the zone and record each one in the property records with the county. Mr. Cornman recommended adding a copy of the letter and a transmittal of property owners to the City files.

**4. Discuss and need for permit fee for new construction within the Airport Zone, as defined by the revised Ordinance.**

The Board discussed the need for a fee to secure a permit for construction in the Airport Zone. All agreed that no fee would be levied, except in cases where outside assistance may be required to conduct a study to determine if the proposed construction might adversely affect aviation safety. In this case, the cost of the study is to be borne by the property owner. James noted that Legal Council advised that this must be included in the Ordinance, and James will see that it's properly included.

**5. Set meeting date to approve the revised Airport Zoning Ordinance.**

Board agreed to hold a meeting on March 23, 2021 at 4:00 pm to approve the ordinance. The ordinance will be placed on the March 23, 2021 Regular City Council Meeting for approval.
