

**RESOLUTION ACCEPTING RESIGNATION OF WILLIAM “BUDDY” ZIMMERMAN,
COUNCIL MEMBER WARD 5**

WHEREAS, after serving the City of Bay St. Louis as Council member since July 2017, William “Buddy” Zimmerman, has resigned from the office of Ward 5 Council member for City of Bay St. Louis effective end of business on August 6, 2024, attached as Exhibit "A"; and

WHEREAS, it is in the best interest of the City to respect his wishes and regretfully accept his resignation.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BAY ST. LOUIS, MISSISSIPPI, AS FOLLOWS:

SECTION ONE: The findings, conclusions and statements of fact contained in the preamble are hereby adopted, ratified and incorporated herein.

SECTION TWO: The resignation from the office of Ward 5 Council member of the City of Bay St. Louis, Mississippi, which has been tendered by William “Buddy” Zimmerman effective end of business August 6, 2024, is hereby accepted, and according to the terms and requirements of Section 21-8-19, Mississippi Code of 1972, as amended, it is hereby acknowledged the he will not be completing his term of office, and that the office of Ward 5 Council member of the City of Bay St. Louis, Mississippi, is hereby declared vacant.

SECTION THREE: This resolution shall take effect and be in force from and after adoption.
