

ORDINANCE NO. 668-08-2024
CITY OF BAY ST. LOUIS, MISSISSIPPI

AN ORDINANCE AMENDING ORDINANCE NO. 631-07-2018 OF THE
CITY OF BAY ST. LOUIS, MISSISSIPPI,
TO ALLOW THE OPERATION OF GOLF CARTS AND LOW SPEED VEHICLES
LEGALLY PERMITTED BY THE CITY OF WAVELAND, MISSISSIPPI
ON CERTAIN PUBLIC ROADS AND STREETS WITHIN THE CITY.

WHEREAS, the City of Bay St. Louis desires to pass an ordinance to allow for the lawful operation of Golf Carts and Low-speed Vehicles which are legally permitted and registered in the City of Waveland, Mississippi to travel on public roads and streets within Bay St. Louis city limits; and

WHEREAS, the City of Bay St. Louis desires to accept and reciprocate the Waveland registration of a Golf Cart and Low-speed vehicle.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAY ST. LOUIS AS FOLLOWS:

SECTION 1. Chapter 82, Article VIII, Section 1 is hereby amended to add Section 82-429 and to read as follows:

Sec. 82-429. WAVELAND REGISTRATION

The legal registration of a Golf Cart or Low-speed vehicle within the City of Waveland will be accepted as a valid registration within the city limits of Bay St. Louis. Any Golf Cart or Low-speed vehicle legally registered with the City of Waveland shall follow all other requirements of Golf Carts and Low-speed vehicles contained in this ordinance.

Proof of legal registration of a Golf Cart or Low-speed vehicle shall be provided by the display of an officially issued permit by the City of Waveland.

SECTION 2. This ordinance shall become effective as provided by law.

After being reduced to writing, the foregoing Ordinance was read and considered, section by section, and then as a whole, whereupon Council Member DeSalvo moved for its adoption, and after a second by Council Member Hoffman, the following roll call vote was had:
