#### Dear Mayor Favre and Members of the City Council,

Thank you for the opportunity to submit this request for funding for fiscal year 2025–2026. Court Appointed Special Advocates (CASA) serves as a lifeline for Hancock County's most vulnerable children—those who have suffered abuse and neglect and who now find themselves under the supervision of the Youth Court. Through the dedication of trained volunteers, CASA ensures each child's voice is heard and their best interests are represented with accuracy, compassion, and integrity.

To date, <u>68</u> CASA volunteers have provided critical advocacy for <u>133</u> children, including <u>44</u> who were residents of incorporated Bay St. Louis at the time of their victimization. In addition to serving foster children, we also support children involved in in-home cases—those in which abuse or neglect has been substantiated but the court allows the child to remain with their family while services are accessed under judicial oversight.

Meeting the needs of these children requires ongoing recruitment, training, and support of committed volunteers. Innovative efforts, such as our work with Remi—Mississippi's only courthouse facility dog—and the implementation of trauma-informed practices like Trust-Based Relational Intervention (TBRI), are helping stabilize placements and promote healing for children who have endured significant early trauma.

CASA offers both a moral and fiscal return on investment. Because our advocates are volunteers, a full year of CASA support costs less than a single month of foster care. Moreover, children with CASA advocates spend less time in foster care and are half as likely to re-enter the system—ultimately reducing both human suffering and the financial burden on the state and local government.

With this letter, CASA respectfully requests the City of Bay St. Louis consider a contribution of **\$2,000** in support of our work on behalf of abused and neglected children for fiscal year 2025–2026. Your support affirms the City's commitment to protecting its most defenseless citizens and ensures that no child in our community walks through the court system alone.

Enclosed you will find the Mississippi statute authorizing municipal support for CASA, along with our year-to-date outcomes and 2025 Community Impact Report. I welcome the opportunity to speak further and thank you for your thoughtful consideration. Together, we can continue to be a voice for the voiceless and a source of hope for Bay St. Louis' most vulnerable children.

§ 21-19-46. Donation to Court Appointed Special Advocates (CASA) authorized; limit on amount

#### Currentness

The governing authority of any municipality is authorized, in its discretion, to donate to any chapter of the Court Appointed Special Advocates (CASA) out of any funds in the municipal treasury; however, the cumulative sum of donations to a chapter may not exceed the amount generated in the municipality by one-fourth ( ½ ) mill on all of the taxable property within the municipality during the fiscal year in which the donations are made. Nothing in this section authorizes the imposition of additional tax.

# Remi the Courthouse Facility Dog

Remi accompanies child victims to court hearings in order to enhance the fact-finding process. Remi also supports child welfare system staff to decrease secondary trauma & prevent burnout.

### Trust-Based Relational Intervention®

Trust-Based Relational Intervention, or TBRI®, is a trauma-informed intervention designed to meet the complex needs of vulnerable children. CASA has partnered with other TBRI® agencies to create a multi-disciplinary team to implement system-wide trauma-informed training within the state of Mississippi.



#### **School Supplies**

Each year, CASA meets the back-to-school needs of school-aged served by the CASA program in Hancock, Harrison, and Stone Counties. After backpacks are assembled, CASA volunteers deliver them to their assigned children.





#### **Candles of Hope**

CASA has partnered with Claiborne Hills Supermarket (Hancock) and Quality Bakery (Harrison & Stone) to provide personalized birthday cakes at to children served by CASA volunteers. This project is supported by the Misfit Street Krewzers, the K. Ryder Foundation, & Community Connection. In Harrison & Stone Counties, Kaiden's Candles of Hope honors the legacy and memory of Kaiden Ryder McGill.



#### CASA Christmas

Christmas Sponsor Drive: Each Christmas, every CASA child across Hancock, Harrison, and Stone Counties received personalized gifts tailored to their wishes.

Child Parties: CASA spreads holiday cheer by hosting Christmas parties for children in foster care across Hancock, Harrison, and Stone Counties.
