## ORDINANCE NO. [insert number] CITY OF BAY ST. LOUIS, MISSISSIPPI

AN ORDINANCE AMENDING BAY ST. LOUIS CITY ORDINANCE NO. 612-04-2017, CODIFIED AS CHAPTER 22, ARTIVLE V, SECTION 174(B) (10), COMMONLY REFERRED TO AS THE NOISE ORDINANCE TO ALLOW FOR OUTDOOR ENTERTAINMENT TO OCCUR UNTIL 11:00 P.M. ON FRIDAY AND SATURDAY.

**WHEREAS**, the City of Bay St. Louis desires to prevent excessive noise and sound in order to preserve, protect and promote the health, safety and living conditions of citizens and visitors; and

**WHEREAS**, the City of Bay St. Louis previously adopted Ordinance No. 612-04-2017, on April 4, 2017, which regulated noise within the city limits; and

**WHEREAS**, the City of Bay St. Louis recognizes the economic impact that establishments utilizing outdoor entertainment bring the City, but also recognizes the importance of peace within the community.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAY ST LOUIS AS FOLLOWS:

Section 22-174 (b)(10) of the original ordinance as previously adopted is herein deleted in its entirety and the following Section 22-174 (b)(10) shall be added in its place, while all remaining sections of the original ordinance remain the same:

SECTION 1. The use of any drum or other musical instrument or sound including disc jockeys and live bands with one or more members for outdoor entertainment for the purpose of attracting attention by the creation of noise, to any performance, show, sale, or display of merchandise as to attract customers to any place of business or entertainment venue after 10:00 p.m Sunday through Thursday and after 11:00 p.m. Friday and Saturday unless prior approval of a time variance has been granted as outlined in Section 22-177.
