The undersigned, EMR Services, LLC (Herein called the Company) does hereby agree to finish a routine service as specified below on the following described equipment.

This service will be furnished from the service commencement date shown below, at the price herein named, and will continue until terminated as provided herein. Either party may terminate this agreement at the end of any one (1) year period by giving the other party (30) days prior written notice.

This service shall include the labor necessary for the making of four examinations **yearly** of the subject equipment, annual CAT 1 testing and making minor adjustments disclosed as reasonably necessary at the time of the routine examination. The commencement date of the agreement is **upon acceptance of both parties.**

**Price:** The price of this service, subject to the terms and conditions included herein, shall be **Six Thousand Seven Hundred Eighty-eight Dollars and Zero Cents (\$6,788.00)** per year, payable quarterly (four payments per calendar year at \$1,697.00).

All work included in the contract price shall be performed during EMR Services, LLC regular working hours of regular working days.

Only the work, specified herein, is included under this agreement. Should callback service, test, preventive repairs or service, remedial repairs or any other work be required, this work will be provided in addition to the contract price with EMR Services, LLC at our current billing rate of \$227.00 per man hour.
