
DESCRIPTION (Insert a written description of the Work):

- A. Complete the following as Described in the attached Change Order from Robert Smith Glass.
 - 1. Replace an additional 44 sq ft (7 pieces) of Solarban 60 over 1 5/16" impact rated glass units in existing curtainwall elevations. Also, (1) glass lite that was originally marked for replacement is no longer being replaced.
 - 2. Furnish and install replacement vinyl between pressure bar and glass of existing curtainwall elevations per proper manufacturer's installation instructions.
 - 3. Furnish and installation of missing pressure bar screws throughout existing curtain wall elevations as per proper manufacturer's installation instructions.
 - 4. Material and labor to seal all curtainwall joints between horizontal and vertical members of existing curtainwall elevations as per proper manufacturer's installation instructions.
- B. Cost for said work shall be based on the attached proposal from Robert Smith Glass, Inc. dated August 7, 2024, and shall be taken from the General Contingency line item on the next Pay Application's Schedule of Values.

RFI DESCRIPTION

GLASS PANELS

The Glass Company, upon removing the face cap from the existing curtain wall at Court St., has identified several issues that need to be addressed:

a. Missing bolts on the pressure bar. (See attached Photo#1)

b. The exterior pressure bar vinyl is short at most horizontals and verticals. (See attached Photo #2)

c. There is a need for 995 sealant where the horizontal and vertical pressure bars meet (See attached Photo #2). These joints must be sealed according to the manufacturer's instructions.

The company has also recommended that additional glass panels be replaced. (See attached drawing)

Please advise on how you would like to proceed with all items mentioned above prior to the reinstallation of the face cap.






