1. Shade texture/tightness may vary w/ structure.
2. Shade Doctor LLC will preform a precision measure of your project at some time during your stated lead time for a second look. At this measure we will calculate bias. Bias is the slope of the concrete, tile or flooring surface. Accounting for bias doesn't solve for "valleys" or "humps" in your flooring surface. Such irregularities may lead to gapping below the vulcanized rubber on the bottom of the bar. Should you not be satisfied with your flooring irregularities Shade Doctor will install 6" vulcanized rubber at a cost of \$325 per opening. This amount is in addition to the stated contract amount.
3. Motorized shades are not 100% weather tight but will allow usage of your outdoor space most of the year without significant disruption from weather.
4. Shade Doctor is not responsible for material shortages/ delays beyond our control. Client will be notified of and such delays ASAP.
5. Our shades are designed for Sun, Wind and Rain Control and Visibility and/or Air Flow will vary with conditions and fabric selection.
