FMA-PJ-04-MS-2022-008 (0)	Executive Order 11988 - Floodplains	EO 11988 CONDITION: All new construction associated with the project must be protected to the 100-year (1% annual chance) flood elevation. Applicant must submit documentation to the State and FEMA documenting compliance with this condition. The applicant must document coordination with the local floodplain administrator before work begins. Failure to comply with these conditions may jeopardize FEMA funding; verification of compliance will be required at project closeout.
	Coastal Zone Management Act (CZMA)	CZMA CONDITION: The subgrantee is responsible for obtaining any required Mississippi Department of Marine Management permits/waivers. Compliance with Office of Coastal Resources requirements constitutes compliance with Mississippi CZMA. Failure to comply with these conditions may jeopardize FEMA funding; verification of compliance will be required at project closeout.
	Executive Order 11988 - Floodplains	EO 11988 Condition: The proposed project is located in a floodplain area; therefore, a floodplain construction permit is required for the property undergoing reconstruction and elevation. A copy of the correspondence must be forwarded to FEMA upon closeout.
	Resource Conservation and Recovery Act, aka Solid Waste Disposal Act (RCRA)	RCRA CONDITION: Unusable equipment, debris and material shall be disposed of in an approved manner and location. In the event significant items (or evidence thereof) are discovered during implementation of the project, applicant shall handle, manage, and dispose of petroleum products, hazardous materials and toxic waste in accordance to the requirements and to the satisfaction of the governing local, state and federal agencies.

Executive Order 11988 - Floodplains EO 11988 Condition: This project is subject to the Hazard Mitigation Assistance (HMA) Federal Flood Risk Management Standard (FFRMS) partial implementation policy (August 26, 2021) requirements. Per the Freeboard Value Approach, the structure(s) must be protected to a minimum of the Base Flood Elevation (BFE) plus two feet of freeboard.
