

ORDINANCE NO. 672-12-CITY OF BAY ST LOUIS, **MISSISSIPPI** AN ORDINANCE AMEND-ING CHAPTER 22, ARTI-CLE IV, SECTION 151 OF THE CITY OF BAY ST. LOUIS CODE OF ORDI-EXPAND NANCES. TO THE DEFINITION OF LIT-TERING AND TO PRE-VENT LITTERING WATER-CANALS AND WAYS WHEREAS, the City of Bay St. Louis, Mississippi, is a duly organized and incorporated municipality pursuant to Title 21, Chapter 8, Section 1, et seq., of the Mississippi Code of 1972, Annotated and all amendments thereto; and 🗐 WHEREAS, pursuant to Title 21, Chapter 17, Section 5, of the Mississippi Code of 1972, Annotated and all amendments thereto; the City governing authorities have the power to adopt any orders, resolutions or ordinances with respect to such municipal affairs, property and finances which are not inconsistent with the Mississippi Constitution of 1890, the Mississippi Code of 1972, or any other statute or law of the State of Mississippi, and shall likewise have the power to alter, modify and repeal such orders, resolutions or ordinances; and WHEREAS, interest significant City; and

the City has among other things, providing a safe, pleasant, and clean environment free from nuisance and littering, and in protecting the preserving the quality of its neighborhoods and aesthetics of the

WHEREAS, the City governing authorities desires to modify its current littering ordinance to combat the placement of tree trimmings and grass cuttings within streets, canals, and water-ways located within the City; and

WHEREAS, the City desires to modify Chapter 22, Article IV, Section 151 of its current ordinance; and

WHEREAS, the Council authorizes the Mayor, or his designee, to sign such documents or take actions that are necessary or required for the effectuation of the amended Ordinance.

NOW, THEREFORE BE IT ORDAINED BY THE MAY-OR AND CITY COUNCIL OF THE CITY OF BAY ST. LOUIS, MISSISSIPPI, RESOLUTION OF THAT THE MAYOR AND CITY COUNCIL OF THE CITY

SISSIPPI ADOPTING ORDINANCE TO AMEND CHAPTER 22-ENVIRON-MENT, ARTICLE IVLIT-TERING, SECTION 151 AS STATED BELOW. Section 1, Section 151 currently reads as follows: Sec. 22-151. - Prohibited. It shall be unlawful for any person to throw,

sweep or place any kitchen waste, refuse, trash, paper, cans, bottles, fruit skins or other material or substance upon the streets, alleys, sidewalks, neutral grounds, municipal buildings and playgrounds, premises. beaches, parks, drainage pipes and ditches, vacant lots, or any other property

within the city. Section 2. Section 151 will

be modified to read as follows:

Sec. 22-151. - Prohibited. It shall be unlawful for any person to throw, sweep or place any kitchen waste, refuse, trash, paper, cans, bottles, fruit skins, tree trimmings, grass clippings, or grass trimmings, or other material or substance upon the streets, alleys, sidewalks, neutral grounds, municipal build-ings and premises, playgrounds, beaches, parks, drainage pipes and ditches, vacant lots, canals, waterways, or any other property within the city.

After being reduced to writing, the forgoing Ordinance was read and considered. section by section, and then as a whole whereupon, Councilman DESALVO moved for its adoption, and after a second by Councilman DAVIS, the following roll call vote was had:
