AMENDING CHAPTER 17.02 "ADMINISTRATION",  
CHAPTER 17.03.120 "PERMITTED USES FOR BASE ZONE DISTRICTS",  
AND CHAPTER 17.19.120 "PERMITTED USES FOR DOWNTOWN BASE  
ZONE DISTRICTS"  
OF THE BEAUMONT MUNICIPAL CODE**

The purpose and intent of this addition is to provide updates to the permitted uses and processes established in the municipal code.

**Beaumont Marketplace Specific Plan Amendment SP2022-008 and Tentative Parcel Map No. 38232 (PM2022-0011)**, Conduct a public hearing and consideration of a request to amend the Beaumont Marketplace Specific Plan to reflect the current intensity of commercial development on the subject parcels including lot area, setbacks, parking, building colors and landscaping; and a request to subdivide 17.3-acres into ten (10) lots for financial purposes. The proposed application is consistent with the Mitigated Negative Declaration (MND) that was adopted for the underlying project, Beaumont Marketplace Specific Plan. APN: 419-260-078, -079, & -080

The applicant for this project is **RRM Design Group**

**Tentative Parcel Map No. 38519 (PM2022-0013)**, Conduct a public hearing and consideration of a request to subdivide 3.5-acres into three (3) lots ranging in size from 0.42-acres to 1.58-acres within the Sundance Specific Plan and located on the northwest corner of 8th Street and Highland Springs Avenue. The proposed application is consistent with the Final Environmental Impact Report (FEIR) that was adopted for the underlying project, Sundance Specific Plan. APN: 419-750-004
