CITY OF BEAUMONT SECOND AMENDMENT TO CHEMICAL SUPPLY AGREEMENT (HASA Inc.)

THIS SECOND AMENDMENT TO CHEMICAL SUPPLY AGREEMENT ("Agreement") is made and effective as of the 1st day of July, 2022 by and between the CITY OF BEAUMONT ("CITY"), and HASA, Inc., a California corporation whose address is 23119 Drayton Street Saugus, CA 91350 ("CONTRACTOR") in consideration of the mutual promises and purpose contained herein, the parties agree as follow:

RECITALS

This Second Amendment is made with respect to the following facts and purpose that the parties agree are true and correct:

- A. On July 1st, 2020 the CITY and CONTRACTOR entered into a certain agreement entitled "Wastewater Treatment Plant Chemical Supply Agreement" ("Agreement"), after following an RFP process to supply Sodium Hypochlorite used in the operation of the Wastewater Treatment Plant.
- B. Term of Agreement states "...this agreement shall automatically terminate after one (1) year unless extended by the parties with the approval of the City Council of the CITY."
- C. On July 1st, 2021 the CITY and CONTRACTOR entered into a First Amendment to Chemical Supply Agreement to extend services.
- D. Term of Agreement states "...this agreement shall automatically terminate after one (1) year unless extended by the parties with the approval of the City Council of the CITY."

AMENDMENT

The Agreement is hereby amended to replace section 4 regarding the Compensation and to extend the 'Wastewater Treatment Plant Chemical Supply Agreement for a one-year term, effective July 1st, 2022.

COMPENSATION

The CITY shall pay the CONTRACTOR at the rates set forth and shall not increase any rate without the prior written consent of the CITY.

TERM
