RESOLUTION NO. 2021-30

RESOLUTION OF THE CITY COUNCIL, ACTING IN ITS CAPACITY AS THE LEGISLATIVE BODY OF CITY OF BEAUMONT COMMUNITY FACILITIES DISTRICT NO. 2021-1 (FAIRWAY CANYON), CERTIFYING THE RESULTS OF THE JUNE 1, 2021 SPECIAL TAX AND BOND ELECTIONS

Intent of the Parties and Findings

- (i) The City Council (the "City Council") of the City of Beaumont, California (the "City"), acting as the legislative body of City of Beaumont Community Facilities District No. 2021-1 (Fairway Canyon) (the "Community Facilities District"), called and duly held elections on June 1, 2021 within the boundaries of the Community Facilities District pursuant to Resolution No. 2021-20 for the purpose of presenting to the qualified electors within the Community Facilities District the propositions which are attached hereto as Exhibit A; and
- (ii) There has been presented to the City Council a certificate of the City Clerk canvassing the results of the elections, a copy of which is attached hereto as Exhibit B;
- NOW, THEREFORE, the City Council of the City of Beaumont, California, acting for and on behalf of the City and the Community Facilities District, does resolve, declare, determine and order as follows:
- SECTION 1. Each of the above recitals is true and correct and is adopted by the legislative body of the Community Facilities District.
- SECTION 2. Propositions A, B and C presented to the qualified electors of the Community Facilities District on June 1, 2021 were approved by more than two-thirds of the votes cast at the election held for the Community Facilities District, and each of Propositions A, B and C for the Community Facilities District has carried. The City Council is hereby authorized to levy on the land within the Community Facilities District the special tax described in Proposition B for the purposes described therein and to take the necessary steps to levy the special tax authorized by Proposition B and to issue bonds in an amount not to exceed \$19,500,000 as specified in Proposition A.
- SECTION 3. The City Clerk is hereby directed to record in the Office of the County Recorder within fifteen days of the date hereof a notice of special tax lien for the Community Facilities District which Bond Counsel to the Community Facilities District shall prepare in the form required by Streets and Highways Code Section 3114.5.
