 - iii) Provide as-built drawings and daily field reports at the completion of the project.
- b) Perform weekly SWPPP inspections on project and submit reports to all parties.
- c) Garver to observe construction testing to be performed by the contractor.
- d) Fee below is based on 20 working days.
- 2) Scope of services does not include the following:
 - i) Construction Testing (Testing to be Contractor Provided)

3) PAYMENT

a) For the Services set forth above, Owner will pay Garver as follows: Thirty Thousand and Eighty Dollars (\$30,080) to be billed Hourly Not-to-Exceed
