5	A RESOLUTION DECLARING THE ENTIRE BOUNDARY			
6	OF THE CITY OF BEL AIRE, KANSAS.

8	WHEREAS, K.S.A. 12-517 requires that the Governing Body of a city declare by			
9	resolution the entire boundary of the city, before the last day of December in any year, in which			
10	territory has been added to or excluded from the city; and			
11				
12	WHEREAS, the Governing Body has approved annexations to the City since the last			
13	boundary declaration, on October 3, 2023.

15	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BEL AIRE, KANSAS:

17	SECTION 1. The entire boundary of the City of Bel Aire, Kansas is hereby			
18	declared to be, and is described as follows:

24	Northeast corner of the Southwest Quarter of Section 13; thence South along the			
25	East line of said Southwest Quarter of Section 13 to the North right-of-way line of			
26	East 53 rd Street North; thence East along the North right-of-way line of East 53 rd

38	quarter; thence South 490 feet to the north right of way line of 53 rd Street North,			
39	thence to the West right-of-way line of Rock Road; thence North along the West
