FY2026 Revenue Neural Rate Hearing & Resolution to Exceed

Revenue Neutral Rate (RNR)

What is the Revenue Neutral Rate?

 The RNR is the tax rate (in mills) needed to generate the same property tax revenue in dollars as levied the previous tax year using the current tax year's total assessed valuation.

How is the RNR calculated?

Last year's total property tax dollars levied

This year's estimated total assessed valuation



RNR - Frequently Asked Questions

I received an RNR notice in the mail. What is this?

- The notice received in the mail shows all the taxing jurisdictions your property is located within. Next to each jurisdiction, shows the amount of property taxes you paid to each jurisdiction in the current year compared to the proposed taxes for the following year.
- In Bel Aire you pay property taxes to the following jurisdictions
 - State of Kansas
 - Sedgwick County
 - Fire District 1
 - City of Bel Aire
 - South Central Kansas Library System
 - USD259 or USD375 (location dependent)
 - Whitewater River Watershed (location dependent)
- The City of Bel Aire only controls its portion of your property tax bill (About 27%)



RNR – Frequently Asked Questions

What is the process to exceed the RNR?

- Notify the County Clerk of the City's intent to exceed the RNR by July 20th. (July 17th)
- Publish the RNR hearing notice on the City website and in a newspaper of general circulation within the county at least 10 days prior to the hearing. (Aug 21st)
- The RNR hearing must be scheduled between Aug 20th and Sep 20th. (Sep 2nd)
- Hold the RNR public hearing and allow all interested taxpayers an opportunity to provide comment. (Sep 2nd)
- Adopt a resolution to exceed the RNR with a roll call vote after all interested taxpayers have been heard, but before the hearing is closed. (Sep 2nd)



RNR – Frequently Asked Questions

What is the RNR for Bel Aire and will Bel Aire exceed the RNR for the 2026 budget?

- The RNR for Bel Aire is 36.760 for the 2026 budget year.
- Yes, Bel Aire is a growing community, and growth requires increases in personnel, infrastructure, services, and maintenance costs. The cost for these items increase every year.

Will I pay more in property taxes if Bel Aire exceeds the RNR?

- Maybe. Your property taxes are determined by the value of your property and the amount of tax dollars levied by each taxing jurisdiction.
- The proposed tax dollars levied for the city portion of your property taxes in 2026 will reduce the current city mill levy by 1.536 mills (42.484 to 40.948). Because the City did not capture its total valuation growth, the amount of property taxes paid in 2026 may be less than 2025.
- The following slide is an example of a \$250,000 home for 2026:
