A RESOLUTION OF THE GOVERNING BODY OF THE CITY  
OF BEL AIRE, KANSAS TO EXCEED THE REVENUE  
NEUTRAL RATE IN ITS PROPERTY TAX LEVY FOR THE  
BUDGET YEAR OF 2026.

WHEREAS, the Governing Body of the City of Bel Aire is statutorily required within K.S.A. 79-2988 to provide a notice and hearing prior to exceeding the Revenue Neutral Rate; and

WHEREAS, the Sedgwick County Clerk was provided notice of the hearing on the Revenue Neutral Rate on the 17<sup>th</sup> day of July, 2025; and

WHEREAS, the Revenue Neutral Rate for budget year 2026 for the City of Bel Aire was calculated at 36.760 mills by the Sedgwick County Clerk; and

WHEREAS, the budget proposed by the Governing Body of the City of Bel Aire for budget year 2026, if approved, will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Governing Body of the City of Bel Aire held a hearing on the 2<sup>nd</sup> of September, 2025 allowing all interested taxpayers an opportunity to be heard; and

WHEREAS, the Governing Body of the City of Bel Aire having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF BEL AIRE:

The City of Bel Aire shall levy a property tax rate exceeding the Revenue Neutral Rate of 36.760 mills for Budget Year 2026.

This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.
