A. BZA Case 25-02 -Variance request for Fence. 2214 Tampico Trail to allow construction of a privacy fence with support posts facing exterior of the west side of the lot.

Bonnie Campbell, 2218 Tampico Trail, asked what is the difference between now and when the original fence went in and said she didn't realize the fence only affected 2210 Tampico so she has no objection.

Mr. Bridge said he thinks Ms. Tanka should talk to her neighbor and thinks the Board should not keep granting variances.
