

ORDINANCE NO. 23-03

AN ORDINANCE OF THE CITY OF BELLE ISLE, FLORIDA, AMENDING CHAPTER 2, ARTICLE III, DIVISION 1 OF THE CITY'S CODE OF ORDINANCES TO CREATE A NEW SECTION 2-82 CONCERNING THE HIRING AND CONFIRMATION OF AN ASSISTANT CITY MANAGER, PROVIDING FOR SEVERABILITY, CONFLICTS, CODIFICATION, AND AN EFFECTIVE DATE.

WHEREAS, in the event the City creates an assistant city manager position, the City Council would like the opportunity to confirm and potentially interview the person that the city manager hires for such position; and

WHEREAS, the City Council determines that the code provisions adopted by this Ordinance are in the City's best interests.

NOW, THEREFORE, be it ordained by the City Council of the City of Belle Isle, Florida, as follows:

SECTION 1. Recitals. The foregoing recitals are hereby ratified and confirmed as being true and correct and are hereby made a part of this Ordinance.

SECTION 2. City Code Amendment. Chapter 2, Article III, Division 1 of the Belle Isle Code of Ordinances is hereby amended to add a new Section 2-82 to read as follows (words that are ~~stricken out~~ are deletions; words that are underlined are additions):

ARTICLE III. - OFFICERS AND EMPLOYEES

DIVISION 1. - GENERALLY

1 Secs. 2-82. Assistant City Manager.

2 If the position of assistant city manager is created, then the city manager's
3 hiring of a person to serve as assistant city manager is subject to confirmation
4 by the city council. The city council may interview the person hired or proposed
5 to be hired as the assistant city manager before confirming such person. If the
6 city manager hires an assistant city manager and the city council does not confirm
7 such a person within thirty (30) days of the effective date of hire, the person
8 will be automatically terminated from the assistant city manager position.

10 SECTION 3. Codification. Section 2 of this Ordinance will be incorporated into
11 the Belle Isle City Code. Any section, paragraph number, letter, and/or any
12 heading may be changed or modified as necessary to effectuate the foregoing.
13 Grammatical, typographical, and similar errors or like errors may be corrected,
14 and additions, alterations, and omissions not affecting the construction or
15 meaning of this ordinance or the City Code may be freely made.

17 SECTION 4. Severability. If any section, subsection, sentence, clause, phrase,
18 word, or provision of this Ordinance is for any reason held invalid or
19 unconstitutional by any court of competent jurisdiction, whether for
20 substantive, procedural, or any other reason, such portion will be deemed a
21 separate, distinct, and independent provision, and such holding will not affect
22 the validity of the remaining portions of this Ordinance.

SECTION 5. Conflicts. If a conflict arises between this Ordinance and any other ordinance or provision of law, this Ordinance controls to the extent of such conflict, as permitted under the law.

SECTION 6. Effective date. This Ordinance will become effective immediately upon adoption by the City Council of the City of Belle Isle, Florida.
