

1 (3) No more than two members shall be employed by the same employer.

3 (b) *Office of planning and zoning board member.*

4 * * * * *

5 (3) *Vacancies on the board.* Any vacancy occurring during the unexpired term of office of any
6 member of the planning and zoning board shall be filled by the council for the remainder of the
7 term within 45 days after the vacancy occurs. The vacancy will be advertised to fill the vacancy by
8 District; however if no candidates apply from the District for that District vacancy, the Council may
9 fill the vacancy from at-large candidates regardless of district residency.

12 **SECTION 2. Codification.** This Ordinance shall be incorporated into and codified within the Land
13 Development Code of the City of Belle Isle, Florida. Any section, paragraph number, letter and/or any heading
14 may be changed or modified as necessary to effectuate the foregoing. Grammatical, typographical, and
15 similar or like errors may be corrected, and additions, alterations, and omissions not affecting the construction
16 or meaning of this Ordinance or the Land Development Code may be freely made.

17
18 **SECTION 3. Severability.** If any section, subsection, sentence, clause, phrase, word or provision of
19 this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction,
20 whether for substantive, procedural, or any other reason, such portion shall be deemed a separate,
21 distinct and independent provision, and such holding shall not affect the validity of the remaining portions of
22 this Ordinance.

1 **SECTION 4. Conflicts.** In the event of a conflict or conflicts between this Ordinance and any other
2 ordinance or provision of law, this Ordinance will govern and control to the extent of the conflict, as allowable
3 under the law.

4
5 **SECTION 5. Effective Date.** This Ordinance shall become effective immediately upon adoption
6 by the City Council of the City of Belle Isle, Florida.
