

1 the City Code provisions governing lot splits so as to ensure that the standards
2 and criteria governing lot splits can be reviewed and revised to eliminate or
3 reduce problems, issues, impacts and concerns associated with lot splits and to
4 ensure that lot splits will be consistent with the City's character, Comprehensive
5 Plan, and the public welfare; and

6
7 **WHEREAS**, the City Council and City Manager have directed the City's planning
8 consultant and City staff to evaluate the problems, issues, impacts and concerns
9 occurring in the City related to lot splits, including without limitation, the
10 increase in densities, the impact on existing homes and the character of
11 neighborhoods, matters pertaining to safety, aesthetics, home and property
12 valuations and other matters; and

13
14 **WHEREAS**, the City has determined that the moratorium imposed by this
15 Ordinance is in the interests of the public health, safety, and welfare; that the
16 moratorium is necessary and is of the minimum duration that will allow the City to
17 study problems associated with lot splits, develop, and adopt new regulations;
18 that the moratorium will not deny property owners the use of their property nor
19 impose an unreasonable burden on such use; that the moratorium imposes a
20 reasonable and non-extraordinary delay on lot splits; that the moratorium will not
21 reduce property values; and that the moratorium will not interfere with reasonable
22 investment-backed expectations; and

1 **WHEREAS**, at a public hearing on June 5th, 2018, the City Council directed
2 the City Attorney's office to prepare this Ordinance imposing a moratorium on lot
3 splits; therefore, this Ordinance and any related ordinance governing lot splits
4 prepared during the moratorium, were and are pending as of June 5th, 2018 in
5 accordance with the pending ordinance doctrine set forth in *Smith v. City of*
6 *Clearwater*, 383 So. 2d 681 (Fla. 2d DCA 1980).

7
8 **NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF BELLE ISLE,**
9 **FLORIDA:**

10 **SECTION 1: RECITALS.** The foregoing recitals are ratified and confirmed as
11 being true and correct and are hereby made a part of this Ordinance.

12 **SECTION 2. TEMPORARY MORATORIUM.** Beginning on the effective date of this
13 Ordinance and continuing for a period of 90 days, a moratorium is hereby imposed
14 upon all lot splits within the City as governed by Section 50-33(6) of the City
15 Code. During the moratorium, the City will not accept, process, or consider
16 applications for lot splits that are governed by Section 50-33(6) of the City
17 Code.

18 **SECTION 3. EXPIRATION & EXTENSION OF MORATORIUM.** The temporary moratorium
19 imposed by Section 2 of this Ordinance expires 90 days from the effective date of
20 this Ordinance. The moratorium may be terminated, renewed, or extended for any
21 period of time by the adoption of an ordinance or resolution of the City Council.

23 **SECTION 4. NONCODIFICATION.** This Ordinance shall not be codified.

1 **SECTION 5. SEVERABILITY.** If any section, subsection, sentence, clause,
2 phrase, word or provision of this Ordinance is for any reason held invalid or
3 unconstitutional by any court of competent jurisdiction, whether for substantive,
4 procedural, or any other reason, such portion shall be deemed a separate, distinct
5 and independent provision, and such holding shall not affect the validity of the
6 remaining portions of this Ordinance.

7 **SECTION 6. CONFLICTS.** In the event of a conflict or conflicts between this
8 Ordinance and any other Ordinance or provision of law, this Ordinance controls to
9 the extent of the conflict, as allowable under the law.

10 **SECTION 7. EFFECTIVE DATE.** This Ordinance shall become effective
11 immediately upon adoption by the City Council of the City of Belle Isle, Florida.
