A RESOLUTION OF THE CITY OF BELLE ISLE, FLORIDA TO AUTHORIZE THE ACTING CITY MANAGER TO ENTER INTO A CONTRACT WITH INTERSTATE CONSTRUCTION SUPPLY CO. INC. FOR THE EMERGENCY REPAIR OF THE BELLE ISLE POLICE DEPARTMENT BUILDING; AND FOR OTHER PURPOSES.

WHEREAS, the building of the City of Belle Isle Police Department located at 1521 Nela Avenue, Belle Isle, FL was improperly insulated to the point where it has become infested with mold; and

WHEREAS, attempts to repair have not been effective in correcting the problem and an inspection of the building resulted in the building being designated as hazardous and the air quality identified several areas of health concerns which require immediate remedy;

WHEREAS, the Belle Isle Police Department law enforcement and admin staff have been displaced; and

WHEREAS, Staff has determined that the Contractor's bid satisfies the bidding requirements for the project to engage in the emergency repair of the City of Belle Isle Police Department Building; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of Belle Isle, Florida:

Section 1. City Council hereby authorizes the Acting City Manager to enter into a contract with Interstate Construction Supply Co. Inc. whom submitted the lowest responding bid in the amount of \$120,660.00.
