## **ORDINANCE NO. 18-09**

AN ORDINANCE GRANTING REPUBLIC SERVICES OF FLORIDA, LIMITED PARTNERSHIP AN EXCLUSIVE SOLID WASTE AND RECYCLING COLLECTION SERVICE FRANCHISE; PRESCRIBING THE TERMS AND CONDITIONS ACCOMPANYING THE GRANT OF FRANCHISE; PROVIDING FOR SEVERABILITY OF CERTAIN PROVISIONS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Council of City of Belle Isle enacted Ordinance 13-08 granting to Republic Services of Florida, Limited Partnership an exclusive solid waste collection and recycling service franchise within the City of Belle Isle; and

WHEREAS, the Council of City of Belle Isle desires to renew the exclusive solid waste collection and recycling service franchise within the City of Belle Isle for a period of one-year;

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Belle Isle as
follows:

SECTION 1. City of Belle Isle deems it necessary, desirable and in the interest of its
citizens to enact an ordinance granting to Republic Services of Florida, Limited Partnership an
exclusive solid waste collection and recycling service franchise within the City of Belle Isle,
Florida, subject to the terms and conditions as specified in the contract signed by the City of
Belle Isle and Republic Services of Florida, Limited Partnership, dated September 25, 2013.
