14	on the city checking accounts for the purpose of protecting the assets of the
15	city and the integrity of the City Manager by having more than one signature or
16	all payments issued by the city; and
17	WHEREAS, for the convenience of the City Council members who are
18	appointed as signatories and as a matter of practicality, more than one
19	Commissioner shall be appointed by the Council as authorized signatories on the
20	city checking accounts.
21	THEREFORE, the City Council of the City of Belle Isle, Florida hereby
