A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF BELLE ISLE, FLORIDA, ESTABLISHING THE AUDITOR SELECTION COMMITTEE IN ACCORDANCE WITH FLORIDA STATUTES SECTION 218.391 "AUDITOR SELECTION PROCEDURES"; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

9 WHEREAS, in accordance with Florida Statutes Section 218.391 the governing 10 body of a municipality shall establish and auditor selection committee for a 11 municipality, for the primary purpose to assist the City in selecting an auditor 12 to conduct the annual financial audit required; and

WHEREAS, the auditor selection committee must consist of at least three members and one member of the auditor selection committee must be a member of the governing body of the City of Belle Isle (the "City") who shall serve as the chair of the committee. An employee, a chief executive officer or a chief financial officer of the City may not serve as a member of the auditor selection committee but may serve in an advisory capacity; and

21 Section 1. Recitals. The above recitals are confirmed, adopted, and 22 incorporated herein and made a part hereof by this reference.

Section 2. Authorization. The auditor selection committee is hereby
established. The committee will be tasked in assisting the City in the selection
an auditor to conduct the annual financial audit required. The City of Belle
Isle Budget Committee shall serve as the auditor selection committee. City

1 Council will appoint one of it's to the Committee to serve as chairperson of the 2 committee.

Section 3. Creation of City Audit Committee; Purpose.

4 (a). There is hereby established a City of Belle Isle Audit Selection
5 Committee to be composed of members of the City's Budget Committee and an
6 elected official appointed by the City Council.

7 (b). The purpose of the Audit Committee is to serve in an advisory 8 capacity to the City Council in the selection of an auditor to conduct the 9 City's annual financial audit and for other purposes as directed by City 10 Council.

Section 4. Duties and Responsibilities.

(a). The Audit Committee shall assist the City Commission in selecting an
auditor, in accordance with the provisions of Section 218.391, Florida Statutes,
to conduct the City's annual financial audit required by Section 218.39, Florida
Statutes.

(b). The Audit Committee shall monitor the annual City audit and the processes relating to the performance of the annual City audit, review the results of the annual City audit, and evaluate the City auditors' performance. The Audit Committee shall perform such other duties as assigned by City Council from time-to-time.

Section 5. Meetings.

(a). The Audit Committee shall meet as often as necessary in order toadequately accomplish its duties.

(b). The Audit Committee, except as may be set forth herein or controlling law, shall operate in a manner consistent with the provisions of Section 2-54 of the City Code.
