

ORDINANCE 18-11

AN ORDINANCE OF THE CITY OF BELLE ISLE, FLORIDA, CHANGING THE ABSENTEE REQUIREMENTS FOR THE TREE BOARD MEMBERS; SEVERABILITY; CONFLICTS AND EFFECTIVE DATE.

WHEREAS, the City Council of the City of Belle Isle Florida created A Tree Advisory Board under Ordinance 17-18; and

WHEREAS, the Tree Advisory Board has established its rules and procedures for meetings; and

WHEREAS, the Tree Board established a requirement for attendance at regularly scheduled meetings of the Board; and

WHEREAS, the Tree Board desires to modify the requirement for attendance at regularly scheduled meetings of the Board;

NOW, THEREFORE BE IN ENACTED BY THE CITY COUNCIL OF THE CITY OF BELLE ISLE, FLORIDA, AS FOLLOWS,

Section 1.

Any member who misses two (2) regularly scheduled meetings in a twelve-month period (calendar year), without cause and without being excused as

specifically approved by the Chairman for each absence ~~Any member who fails to attend two of three successive meetings without cause and without proper approval of the Chairman shall automatically forfeit his or her appointment and the City Council shall promptly fill such vacancy. Members may be removed for cause by the appointing authority upon written charges and after a public hearing.~~

Section 2. Severability

If any section a portion of this ordinance proves to be invalid unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force or effect of any other section or portion of a section or subsection or part of this ordinance.

Section 3. Conflicts

That all parts of ordinance in conflict herewith are hereby repealed.

Section 4. Effective Date

This ordinance shall take effect immediately upon its final passage and adoption.
