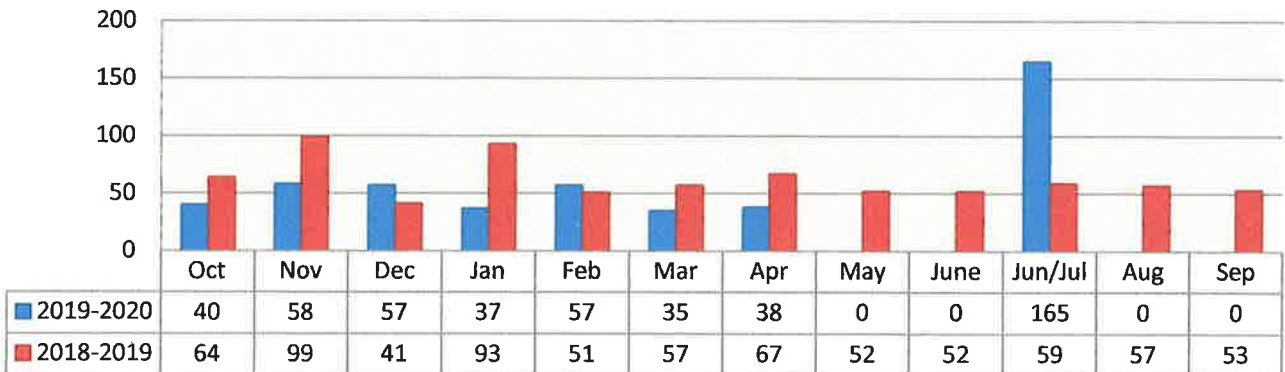

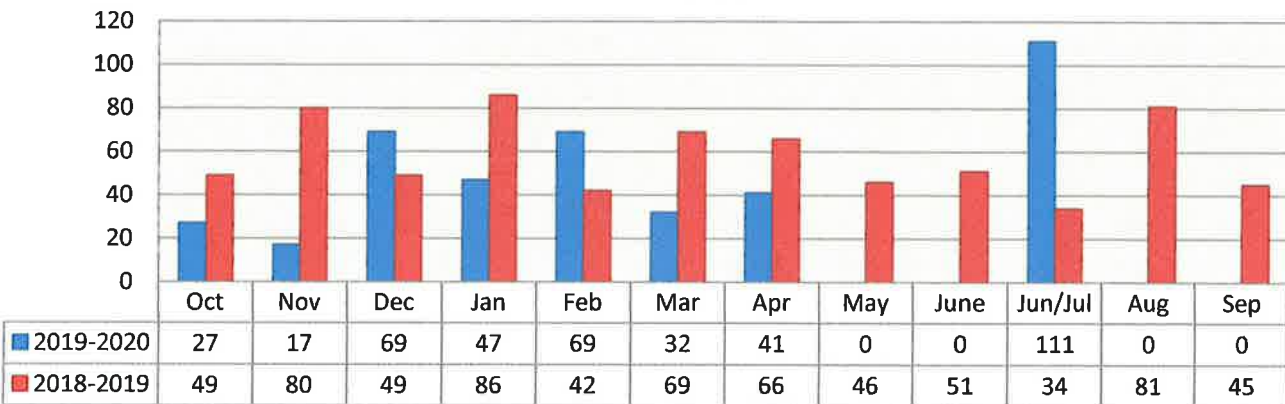

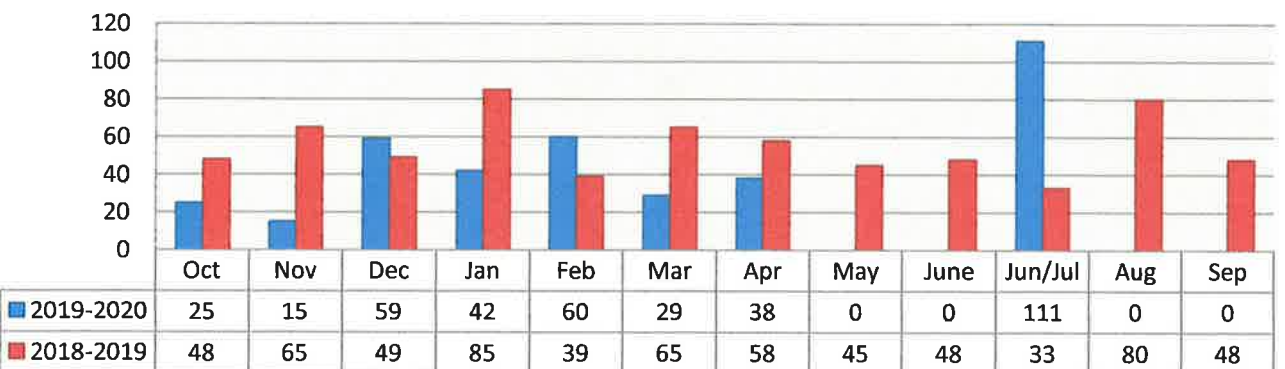
New NOV's Issued 2018/19 vs 2019/20

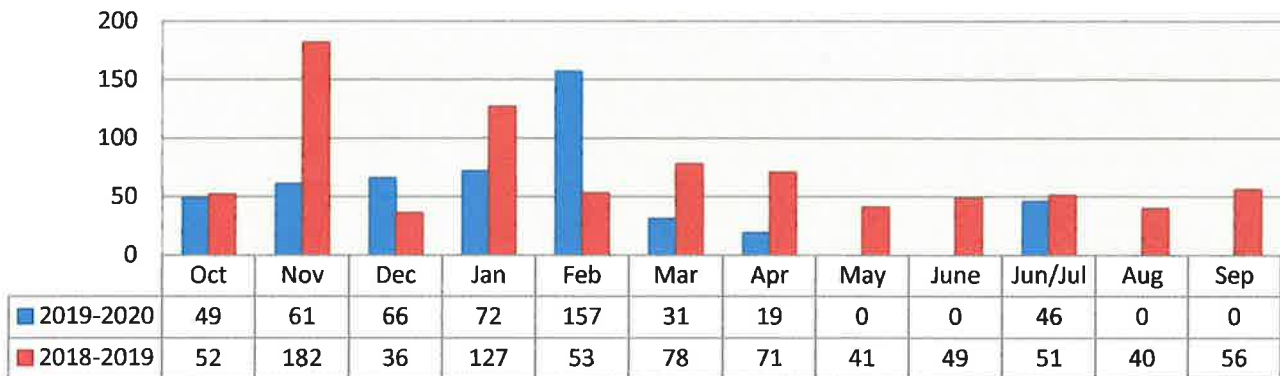

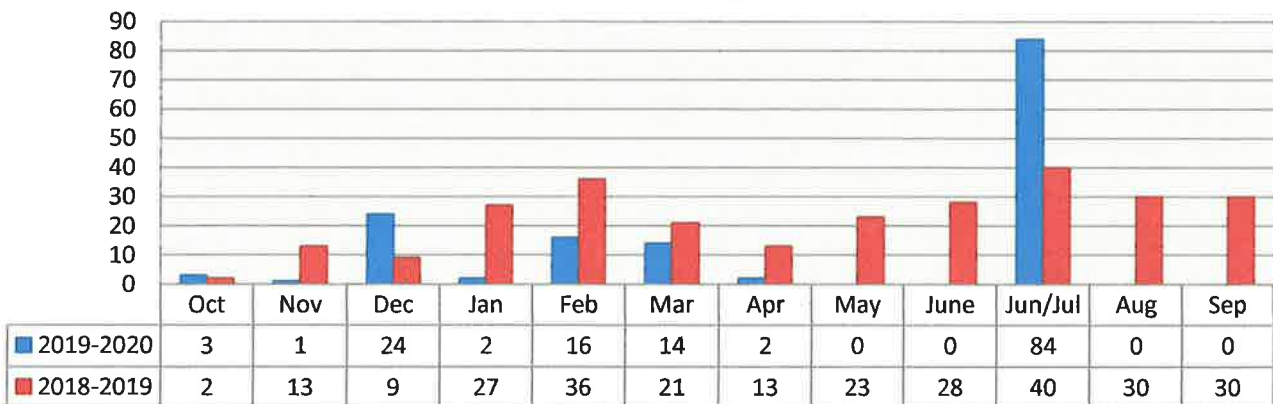

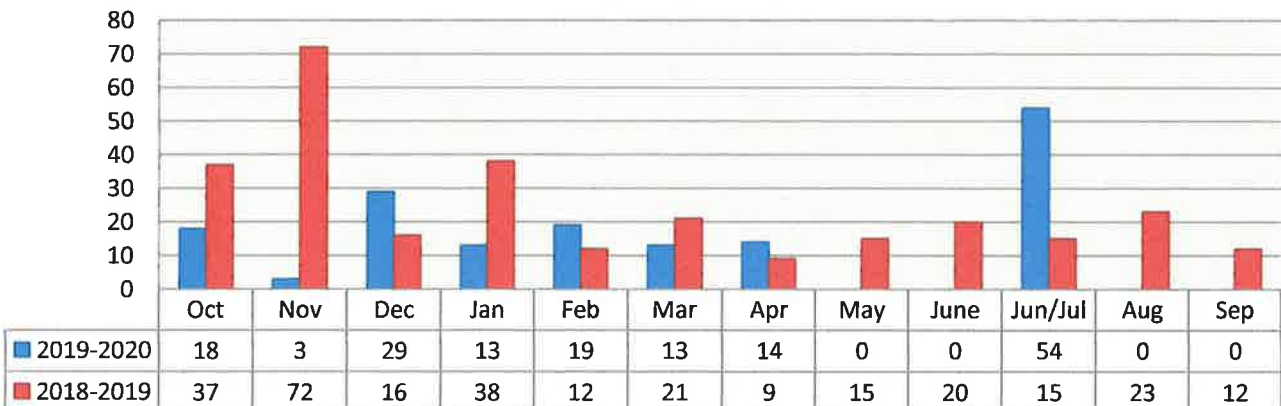

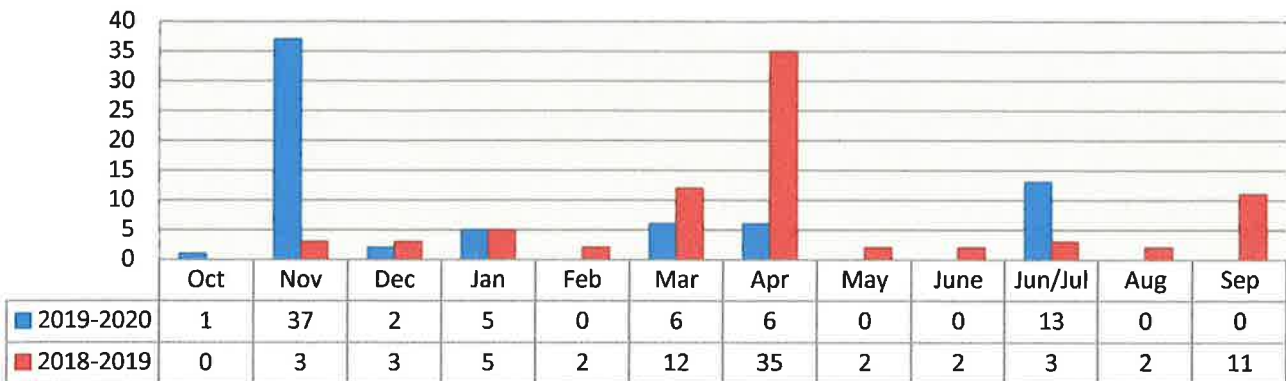

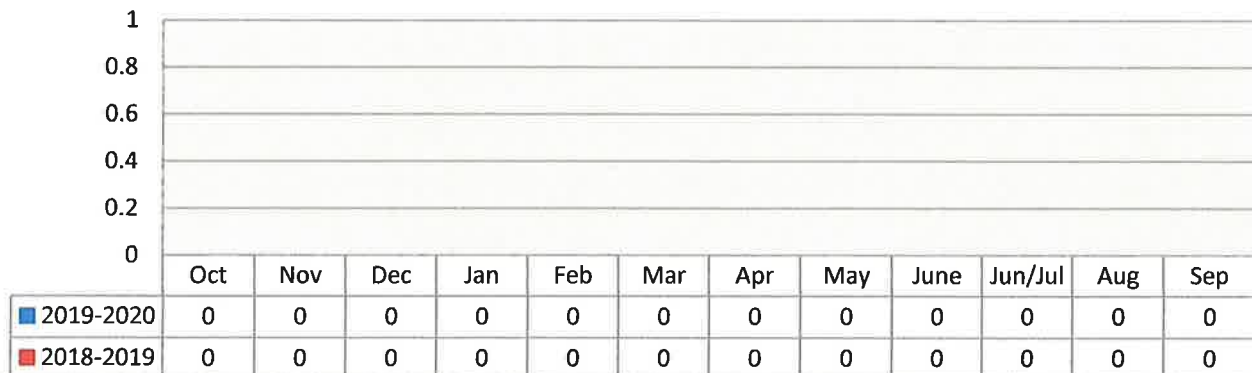

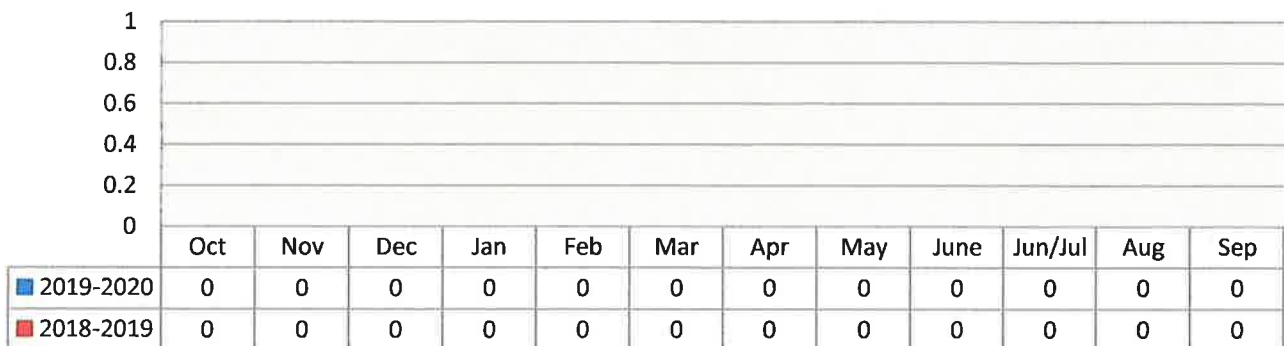
