5. Electronic Recycling Update Discussion
 - Belle Isle will order 25 signs to distribute throughout the community to remind everyone of the Electronics Recycling on 2/20/21.
 - Steve Jackson would like to see flyers for the Electronic Recycling Event. Richard will have Yolanda send to the committee members.
 - Richard Weinsier will organize a sign distribution plan and Clay Van Camp, Kate Durni, Steve Jackson will help distribute.
 - Richard Weinsier stated yard signs will be distributed 2/19/21.
 - Richard Weinsier wanted additional postings about Recycling Notice outside of Belle Isle Facebook Page. Kate Durni will post on her FB pages.
 - Richard Weinsier and Steve Jackson volunteered to attend the Recycling Event on 2/20/21.
6. Update from Waste Provider – JJ's Darrell Corbett VP, Darren Bateson - Branch Manager
 - Darrell Corbett stated:
 - Total Collection for 2020 – 5147.71 Tons; (Yard Waste: 1378.03 Tons, General Waste: 3180.39 Tons, Recycling: 589.29 Tons.)

- General Waste Collection was the highest since 2016(2619.22 Tons). Roughly 561 more Tons collected.
- Recycling is the highest since 2016 as well. Roughly 100 Tons more collected for the highest amount reported.
 - Good News - Recycling remains at zero loads rejected from Orange County Recycling Facility for all of 2020. This does not mean the entire load is recycled. However, it means the loads have an acceptable amount of non-recycling material and OC are accepting the entire loads.
- JJ's has seen the tonnage starting to normalize since the COVID lockdown. Darrell expects 2021 Total Tonnage to be lower over 2020.
- JJ's may communicate a different day for Christmas Tree pickup for 2021.
- No citizen complaints reported for December.
- JJ's will set up a call with Clay Van Camp to go over FY19/20 financials.
