ORDINANCE NO. 16-06

AN ORDINANCE OF THE BELLE ISLE CITY COUNCIL REPEALING CHAPTER 2 ADMINISTRATION, ARTICLE II COUNCIL, DIVISION 2 MEETINGS, SECTIONS 2-53, AND AMENDING CHAPTER 2, ARTICLE II, SECTION 2-51, PROVIDING SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Charter of the City of Belle Isle, Article III, Section 3.08, provides that the City Council shall meet regularly at least once in every month; and

WHEREAS, the City Council of the City of Belle Isle, Florida, is authorized by Article III, Section 3.08 of the City Charter to set by rule the time and place for Council meetings;

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Belle Isle, Florida as follows:

SECTION 1. That Chapter 2, Article II, Division 2, Section 2-53 – Work Sessions of the Belle Isle Code of Ordinances is hereby repealed and any other language pertaining to Regular Work Sessions that conflicts with this Ordinance are hereby repealed.:

SECTION 2. That CH 2, ART II, SEC 2-51 of the Belle Isle Code of Ordinances is hereby amended as follows:

- a) Established. The city council shall hold its regular meetings at city hall on the first Tuesday and third Tuesday of each and every month commencing at such time as the council may prescribe by rule.

SECTION 3. SEVERABILITY. If any word, phrase, sentence, clause or other portion of this Ordinance is determined to be invalid, void, or unconstitutional, the remainder of this Ordinance shall remain in effect.

1 **SECTION 4. EFFECTIVE DATE.** This ordinance shall become effective immediately from its
2 date of adoption.
