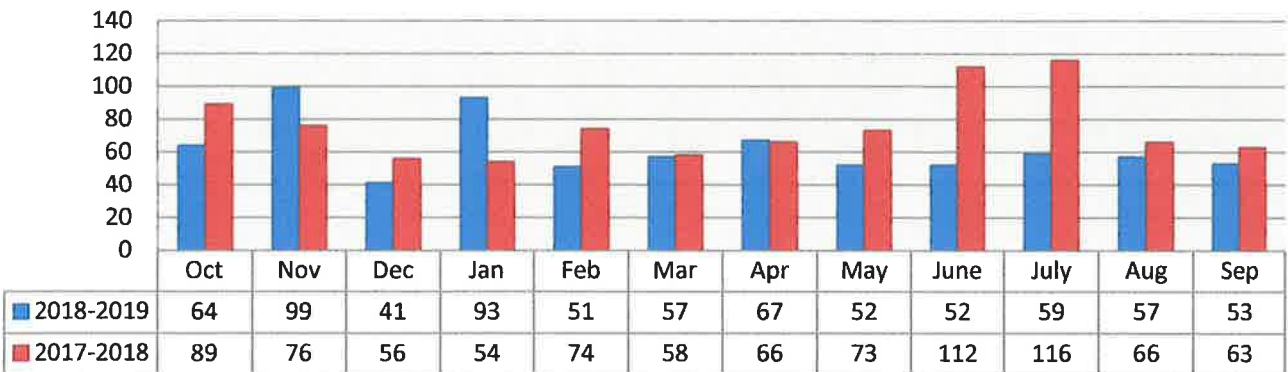

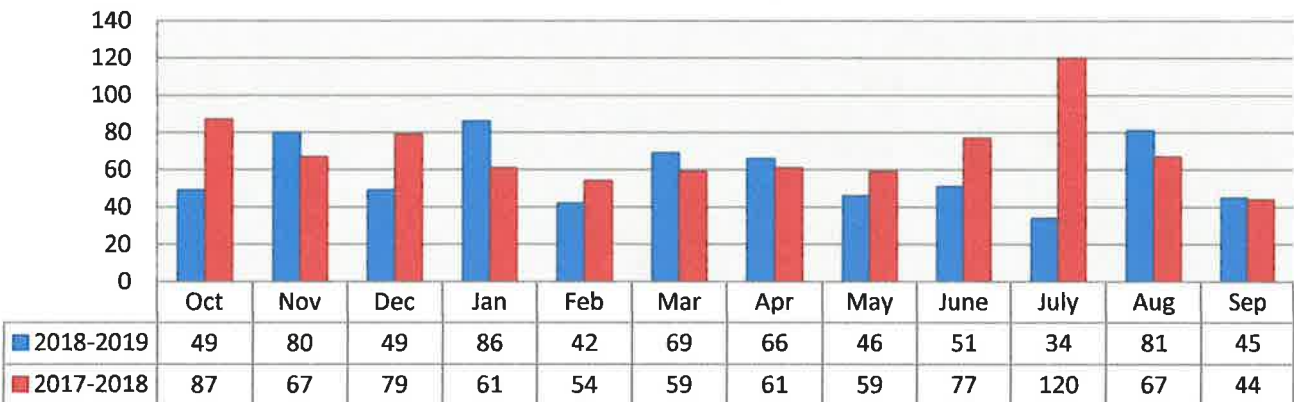

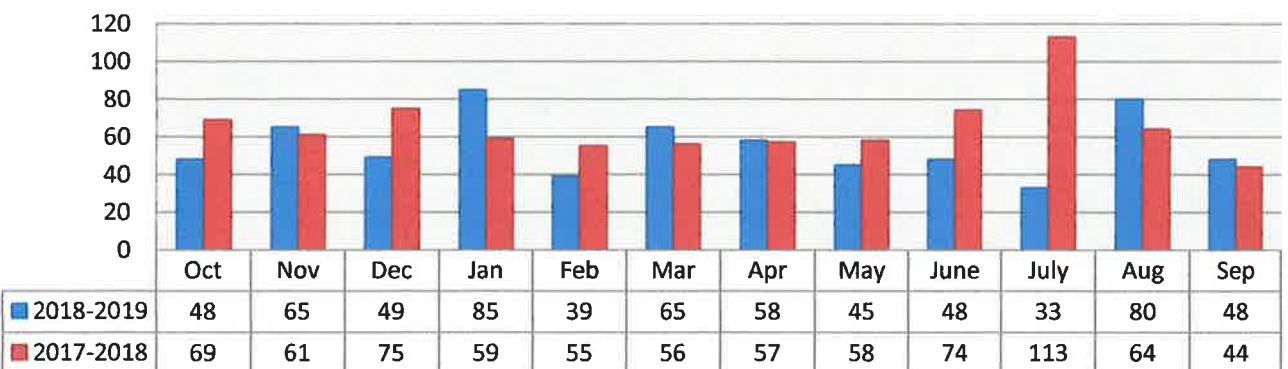
### New NOV's Issued 2017/18 vs 2018/19



### Inspections 2017/18 vs 2018/19

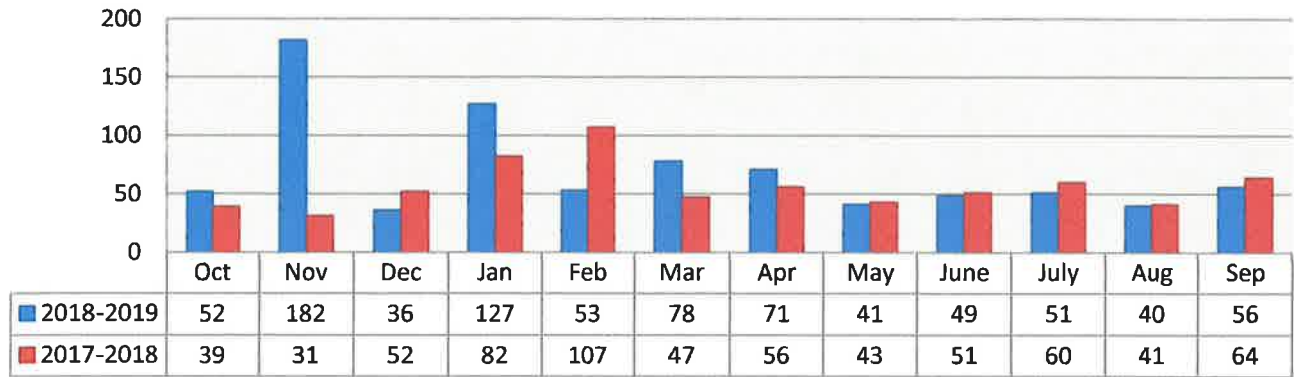

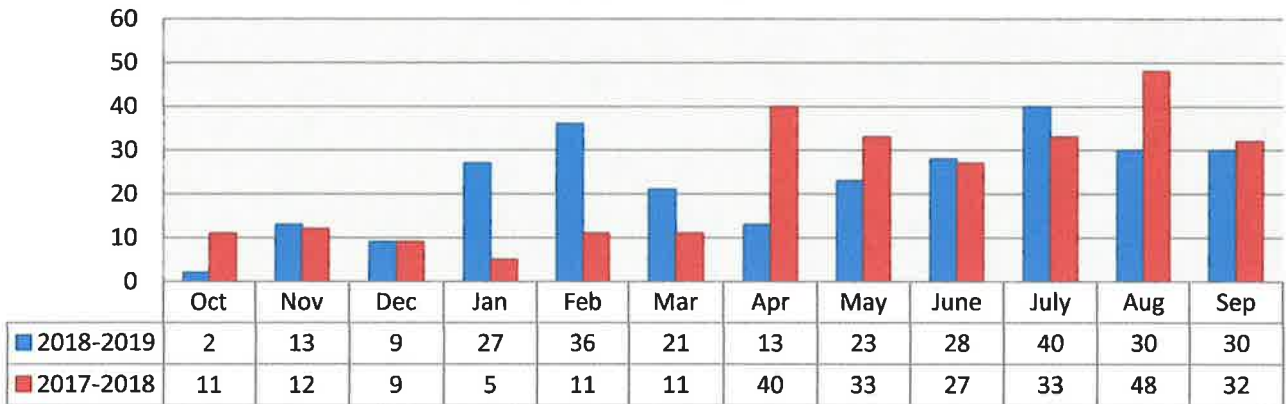

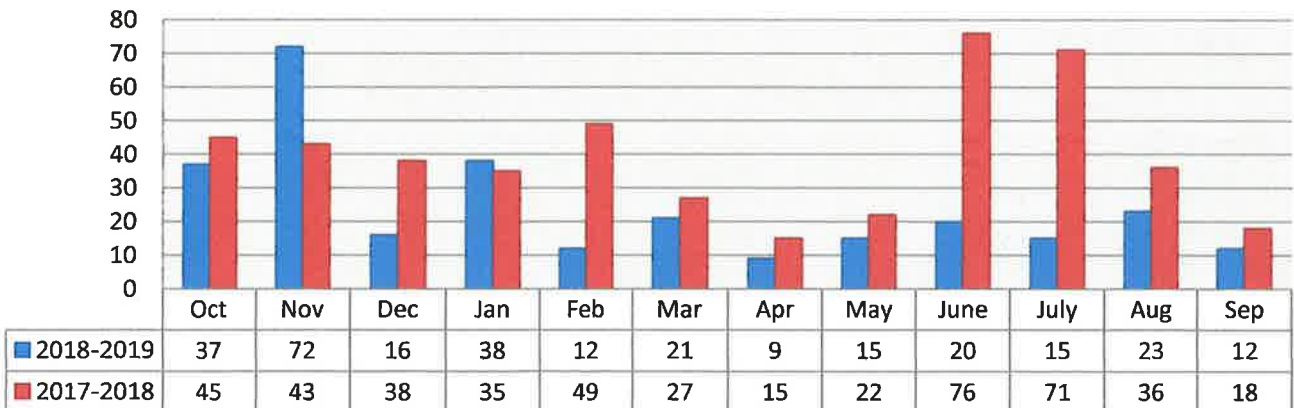
