9	policies subject to approval by the city council by resolution; and							
10	WHEREAS, City employees endured a challenging year due to COVID 19, while dealing with stressful							
11	situations, and some of the City employees being front-line first responders; and							
12	WHEREAS, the City Council of the City of Belle Isle is desirous of enacting such an policy to provide							
13	for payment of monetary bonuses to its officers and employees:							
14	NOW, THEREFORE, IT IS RESOLVED BY THE CITY COUNCIL FOR THE CITY OF BELLE ISLE:							
15	SECTION 1. Recitals. The foregoing recitals are incorporated herein and found by the City							
16	Council to be true and correct statements as to the legislative findings of the City Council.							
17	SECTION 2. The Employee Bonus policy is approved and will be incorporated in the Employee							
18	Personnel Manual.							
19	SECTION 3. That all full-time employees will receive a one-time appreciation bonus of \$1,000.							
20	SECTION 4. Severability. If any section, subsection, sentence, clause, or phrase of this							
21	Resolution is, for any reason, held to be unconstitutional by a court of competent jurisdiction, such holding							
22	will not affect the validity of the remaining portions of this Resolution.							
23	SECTION 5. Effective Date. This Resolution will take effect immediately upon adoption.
