

RESOLUTION NO. 26-06

A RESOLUTION OF THE CITY OF BELLE ISLE, FLORIDA, REPEALING THE PURCHASING POLICY FOR THE CITY OF BELLE ISLE ADOPTED BY RESOLUTION NO. 20-08 AND AMENDED BY RESOLUTION NO. 25-02; ADOPTING AN UPDATED PURCHASING POLICY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 5.12 of the Charter of the City of Belle Isle establishes purchasing requirements and establishes the City Manager as the purchasing agent for the City; and

WHEREAS, on July 7, 2020, the City Council adopted a Purchasing Policy via Resolution No. 20-08 ("Existing Policy"); and

WHEREAS, on January 21, 2025, the City Council amended the Purchasing Policy via Resolution 25-02; and

WHEREAS, the City desires to significantly revise the Purchasing Policy to better comply with state and federal grant guidelines and to clarify the procurement process; and

WHEREAS, the scope of revisions to the Purchasing Policy necessitates a replacement of the Existing Policy with a new Purchasing Policy ("New Policy");

and

WHEREAS, the proposed New Policy is in compliance with applicable Florida Statutes and federal guidelines; and

WHEREAS, the City Council of the City of Belle Isle finds that this Resolution is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Belle Isle,
Florida, that:

SECTION 1. Recitals. The foregoing recitals are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution.

SECTION 2. The Belle Isle City Council hereby repeals the Purchasing Policy adopted by Resolution No. 20-08 as amended by Resolution No. 25-02.

SECTION 3. The Belle Isle City Council hereby adopts the Purchasing Policy attached hereto as Exhibit A.

SECTION 4. Effective date. This Resolution shall become effective immediately upon adoption by the City Council of the City of Belle Isle, Florida.
