



1           WHEREAS, after first reading of this Ordinance, the proposed comprehensive  
2 plan and Water Supply Facilities Work Plan will be transmitted to the Department of  
3 Commerce and review agencies; and

4           **WHEREAS**, the proposed Water Supply Facilities Work Plan, attached hereto as  
5 Exhibit "A" will promote and protect public health safety and welfare and will help  
6 accomplish the goals, objectives and policies of the City's Comprehensive Plan.

7  
8           **IT IS HEREBY ORDAINED BY THE CITY OF BELLE ISLE AS FOLLOWS:**

9  
10          **SECTION 1. RECITALS.**    The above recitals are true and correct and  
11 incorporated herein as legislative findings of the City Council.

12  
13          **SECTION 2. ADOPTION.**   The City of Belle Isle hereby amends the City of Belle  
14 Isle Comprehensive Plan to adopt the Water Supply Facilities Work Plan as set forth  
15 in **Exhibit "A"** attached hereto.   The Water Supply Facilities Work Plan will be  
16 codified into the Comprehensive Plan in accordance with general law.

17  
18          **SECTION 3. EFFECTIVE DATE.**   The effective date of the Comprehensive Plan  
19 Amendment adopted by this Ordinance, if the amendment is not timely challenged,  
20 shall be in accordance with general law, which is 31 days after the State Land  
21 Planning Agency notifies the City that the Comprehensive Plan Amendment package is  
22 complete. If timely challenged, in accordance with general law the amendment adopted  
23 by this Ordinance does not become effective until the State Land Planning Agency or

1 the Administration Commission enters a final order determining the adopted amendment  
2 to be in compliance.

3  
4 **SECTION 4. CONFLICTS.** In the event of a conflict or conflicts between this  
5 Ordinance and any other ordinances or part thereof, this Ordinance controls to the  
6 extent of the conflict.

7  
8 **SECTION 5. SEVERABILITY.** If any part of this Ordinance is found to be invalid,  
9 preempted, or otherwise superseded, the remainder shall nevertheless be given full  
10 force and effect to the extent permitted by the severance of such invalid, preempted,  
11 or superseded part.
