#### **BACKGROUND:**

In accordance with the grant process, the Accommodations Tax Advisory Committee (ATAC) held a meeting on May 16, 2023 to review the quarterly applications. There were five (5) applications to review and make recommendations of funding to Town Council.

#### **Funds Currently Available for Distribution:**

When comparing the estimated State and Local Accommodations Tax collections for the quarter ending March 2023 to the same quarter of last year, the revenues are down \$238,400.05 or approximately 43.7%. Timing in receipt and processing is contributing to some of the decrease.

Total estimated State and Local Accommodations Tax funds currently available for distribution are \$2,781,156 as outlined in the following chart:

#### **Funds Requested for Distribution:**

- □ Society of Bluffton Artists (SoBA) requested \$15,000 in support of advertising and promotion of tourism for Promoting the Arts in the Lowcountry and Beyond.
  - The gallery/education center is located at 6 Church Street in Old Town Bluffton and is currently going through a rebranding process to update its logo.
  - To grow media presence and expand advertising of monthly and seasonal community arts events and activities offered.
  - Eligible "tourism-related expenditures" include:
    - "Advertising and promotion of tourism" is budgeted at \$30,000 for regional marketing via weekly ads in local newspapers, area map, Chamber Vacation Planner, online magazines and social media outlets, ads in LOCAL LIFE Magazine, rack cards placed at hotels and airports, posters, website fees, and Google ads.

#### The committee voted to recommend a total award of \$15,000 presented in the chart below:

- ☐ Hilton Head Symphony Orchestra requested \$48,628 to support advertising and promotion of tourism and facilities for civic and cultural events for the 2023 Bluffton Concerts.
  - There are two events scheduled; the Outdoor Pops concert in October 2023 to coincide with the Historic Arts & Seafood Festival and a Holiday Pops concert held on November 25, 2023 at St. Gregory the Great Catholic Church.
  - The project is a continuation of the long-range goal of regular, annual concerts presented in Bluffton.

- Eligible "tourism-related expenditures" include:
  - o "Advertising and promotion of tourism" is budgeted at \$18,000.
  - o "Promotion of the Arts & Cultural Events" is budgeted at \$3,500.
  - o "Facilities for cultural events" is budgeted at \$27,128 for stage and tent rentals.

#### The committee voted to recommend a total award of \$48,628 presented in the chart below:

### ☐ Historic Bluffton Foundation (HBF) requested \$150,000 to support the Welcome Center at the Heyward House.

- The Heyward House serves as the Town of Bluffton's official Welcome (Visitors) Center.
- The request of \$150,000 is approximately 84% of the Welcome Center's budget and 53% of the entire HBF budget.
- This year's request is \$25,000 or 14% less than last year's annual request of \$175,000.
- Total visitors for FY2022 was 16,423 with approximately 88% of those being from out of town.

- Eligible "tourism-related expenditures" include:
  - "Advertising and promotion of tourism" is budgeted at \$10,250.
  - "Arts & Cultural Events" is budgeted at \$1,250 for tours and events.
  - "Operating Visitor Information Center" remaining amount requested is \$138,500 and qualifies per SC Revenue Ruling #98-22, "expenditures that will qualify under this category are any monies spent to operate and maintain centers whose primary purpose is to provide information, brochures, and other services to tourist."
    - Operating Expenses of \$138,500 include personnel, mortgage and utilities, equipment upgrades and contract services for the Heyward House.

The committee voted to recommend a total award of \$150,000 presented in the chart below:

- □ Bluffton MLK Observation Committee requested \$20,000 to support advertising and promotion of tourism, facilities for civic and cultural events, municipality services, and tourist transportation for Bluffton Juneteenth Celebration, with ATAC recommending \$20,000.
  - This event is scheduled to be held June 16 18, 2023 at the Burnt Church Distillery.
  - The project is aimed at bringing overnight guests to the event with it being held over a weekend.
  - Eligible "tourism-related expenditures" include:
    - "Advertising and promotion of tourism" \$10,000 recommended.
    - "Facilities for cultural events" \$5,000 for stage and tent rentals.
    - "Municipality services" \$3,600 based upon % of tourist attendance.
    - o "Tourist transportation" \$1,400 based upon % of tourist attendance.

The committee voted to recommend a total award of \$20,000 presented in the chart below:

## ☐ BlacQuity SC requested \$28,135 to support advertising efforts for the updated Roots & River Festival project.

- This is the first request from BlacQuity for an event to be held on September 9, 2023 at Oyster Factory Park from 4 pm-9 pm.
- The original total budget for the oyster roast project was \$67,925 with approximately 41% or \$28,135 requested. During the ATAC, the project presented was amended from an oyster roast to a Roots & River Festival.
- Due to the change in scope and budget, ATAC recommended BlacQuity submit an amended application by the upcoming June 30, 2023 quarterly deadline to request any additional allowable expenses.
- ATAC recommended \$11,000 advertising and promotion for the updated Roots & River Festival presented and not for any branding expenses.
